THE NO CONTACT ORDER, WHICH WAS SERVED ON SEPTEMBER 15TH, 2016, LISTED [REDACTED] AS THE PROTECTED PARTY AND MATUTE AS THE SUBJECT HE WAS PROTECTED FROM. BASED UPON THE ABOVE FACTS, THERE IS PROBABLE CAUSE FOR THE ARREST OF MIRIAM MATUTE FOR VIOLATING THE CONDITIONS OF A NO CONTACT ORDER AS MIRIAM MATUTE DID WILLFULLY, AFTER HAVING BEEN SERVED WITH AN INJUNCTION FOR PROTECTION AGAINST DOMESTIC VIOLENCE ISSUED PURSUANT TO SECTION 741.30 GO TO OR BE WITHIN 500 FEET OF THE RESIDENCE OF THE VICTIM, [REDACTED].
