

(Specifically include facts constituting cause for arrest.)</p> <p>On Saturday, March 24th, 2018, at approximately 2238 hours, the Riviera Beach Police Department received a call from a concern citizen regarding a subject "possibly on drug", knocking loudly on their front door for forty five minutes. The caller, who was in fear, stated they did not know who the subject was. The caller informed responding units that the subject, who was described as a white female wearing a dress, was last seen walking around their property.</p> <p>Upon arrival on scene, officers came in contact with the caller who informed officers that the subject went to the rear of the property. Officer N. Mordechay, Ofc. A. Lambert and Ofc. Johnson came in contact with a white female, later identified as Misty D. Mullen 10/20/1980, passed out in the rear of the property. Mullen, who was in a deep sleep appeared to be extremely intoxicated. She had a strong odor of an unknown alcoholic beverage emanating from her person and her breasts were exposed. Mullen was instructed to get up and walked towards the front of the residence. While attempting to stand Mullen fell forward. Mullen, who did not reside on the property, could not walk on her own without assistance. Mullen's eyes were blood shot and her speech was slurred. Mullen, who became belligerent and started to yell inaudible words in a loud tone of voice, did not know her full name, address or her whereabouts. Mullen, who was not cooperating was detained pending further investigation. As Mullen was being escorted to the marked police vehicle, she became agitated and refused to get in the vehicle as she uttered "why am I being arrested?".</p> <p>Based on the above information, Mullen was charged with one count of Disorderly Intoxication per FSS 856.011. Mullen was processed at the Riviera Beach Police Department and later transported to the Palm Beach County Jail.</p>
