NARRATIVE: I am part of a National Task Force known as the South Florida Internet Crimes Against Children (ICAC). This task force investigates internet crimes against children, child exploitation, and related cases.

On 8/16/16, I located Internet Protocol (IP) address 107.207.119.102 in a database maintained by law enforcement and utilized by federal and state law enforcement agencies in child exploitation investigations nationwide. This database maintains a log of IP addresses that have been previously involved in the possession and distribution of videos/images involving the sexual conduct of a child. Files are automatically compared to a known set of hash values as contained in the database that have been identified as the sexual conduct of a child from previous investigations by other law enforcement officers. A hash value is a mathematical function which is used to produce a unique digital signature of a file. The data acquired, including hash value, IP address, name of the file, date and time it was identified by the database provided from the suspect computer, are all logged.

A query done on the database for Palm Beach County, Florida, revealed IP Address 107.207.119.102 was logged for sharing digital movie files on the EDonkey Network on dates ranging from 12/23/15 through 8/16/16. I was able to view several video files that were the same files having been seen from IP address 107.207.119.102, based upon the same hash value, such as: Video File Name: Ggg Cum Orgy Compil 3.avi. This video file depicts a prepubescent female on a bed with her skirt pulled up exposing her genitals. The female is performing oral sex on an adult male. The adult male undresses her and performs oral sex on her. The adult male then has intercourse with the juvenile.

IP address 107.207.119.102 was confirmed to be owned by AT&T. On 8/17/16, I requested the Palm Beach County State Attorney's Office issue a subpoena to AT&T for the IP Address. I requested the subscriber information and IP logs, which specifically corresponded to the dates and times that this IP was seen as having been available for sharing the files listed, being 7/1/16 at 2:07 GMT; 7/6/16 at 3:16 GMT; and 8/7/16 at 00:59 GMT.

NARRATIVE CONTINUATION

On 8/18/16, AT&T responded to the subpoena advising that IP Address 107.207.119.102 was dynamically assigned to AT&T customer Mitchell Rosenblatt, residing at 10751 Lady Palm Lane, Unit B, Boca Raton, FL 33498, # 561-843-2609.

On 12/17/16, a second subpoena was issued to AT&T for IP Address 107.207.119.102 requesting the subscriber information and IP logs from 12/1/16 at 00:01 GMT through 12/7/16 at 1100 GMT. The second subpoena corresponded to the dates and times that this IP was seen as having been available for sharing files involving the sexual conduct of minors. On 12/17/16, AT&T responded to the subpoena advising that IP Address 107.207.119.102 was dynamically assigned to AT&T customer Mitchell Rosenblatt, residing at 10751 Lady Palm Lane, Unit B, Boca Raton, FL 33498, #561-843-2609.

On 1/27/17, I appeared in front of Honorable Judge Glenn Kelley and obtained a search warrant for the residence of 10751 Lady Palm Lane, Unit B, Boca Raton, FL 33498.

On 1/31/17, the search warrant was executed and contact was made with Mitchell Scott Rosenblatt. Post Miranda Rosenblatt admitted to searching and viewing numerous video involving the sexual conduct of minors from December 2015 to present. While an on-scene preview of 3 devices seized met with negative results in locating images/videos involving the sexual conduct of minors, digital forensics later completed at the PBSO Digital Forensics Lab located numerous child pornographic videos on all three devices.

Based on my investigation and digital evidence gathered I am now requesting an arrest warrant be issued for Mitchell Rosenblatt for 7 counts of Possession of the Sexual Performance by a Child, contrary to F.S.S. 827.071(5).
