On December 13th 2017 at approximately 19:30, I was dispatched to Macys - 10300 Forest Hill Blvd, Wellington FL 33414 in reference to a retail theft.

Upon arrival I met with Loss Prevention Officer Dwaine White who stated that he had watched via CCTV as an unidentified white male entered the Lacoste section of Macys and begin selecting a pink shirt and then gray Lacoste beanie and place it under the pink shirt. The male, later identified as Mohammed Yousfi, then selected a white Lacoste shirt and then a gray long sleeve Lacoste sweater before proceeding to the childrens department.

The male then proceeded to select a boys Nike shirt and boys Polo long sleeve shirt before entering the boys fitting room. Upon exiting the fitting room, Yousfi had concealed the items, as they were not left in the fitting room. Yousfi was then observed moving to the Mens department and dumped the sensors that he had taken off of the clothing into a pair of pants. Yousfi then made his way to the Mall exit, passing all points of sale and did not attempt to pay for his concealed merchandise.

White stated that he then dispatched another asset protection detective to pick up the Yousfi. Yousfi was apprehended and complied and was then escorted back to Macys Asset Protection Office without incident.

Yousfi was read his Miranda Rights, and then admitted to concealing the stolen merchandise. Yousfi was then placed into handcuffs which were double locked, and checked for proper spacing. Yousfi was then escorted to the Wellington Green Mall security office.

Mohammed Yousfi was found to be in possession of \$316.00 worth of stolen merchandise and was placed under arrest pursuant to F.S.S 812.014 (1). The entire incident was captured via CCTV. Yousfi was searched incident to arrest for drugs and weapons which proved negative results. Yousfi was placed into the back of my patrol car and taken to Gun Club CJ without incident.

This case is cleared by arrest, nothing further.
