Hooker, stated her daughter (W/F Morgan Ducar 11/24/1984), got home from being out all night and broke the sliding glass window. Northcom stated the female left the residence and is running towards North Central Blvd in a green striped dress. Upon arrival, I made contact with Morgan near the entrance to Riverwalk. Morgan advised the following:

Morgan was noticeably upset and had blood coming from her right knee, right hand and had some blood behind her left knee. Morgan stated she was in an argument with her brother, Brandon Ducar (03/29/1981), and her mother. Morgan advised she is having a hard time because she has not seen her 6 year old son in a while. She advised "everyone thinks I am better without my son," and her son is with his father. She advised things just escalated between her and her brother. While speaking to Morgan, there was a strong odor of an unknown alcoholic beverage coming from her. Morgan advised she was bleeding because she was throwing things in the house and threw something through the window causing it to break. At no point did Morgan advised she was in a physical argument with Brandon or that she hit him in anyway.

After walking to the residence, I walked into the residence and observed broken glass all over the floor. There was blood throughout the house on the floor. Rene was inside the residence and advised there was a mirror that was on the wall which was smashed on the ground. The glass door that was in the back of the kitchen had a large hole in it, and I observed a broken alcohol bottle on the ground along with the glass from the door.

I then spoke with Brandon who was in shock, upset, and angry about what just happened. Brandon advised he was missing money and his prescription medication. He advised he was asleep in his room and when he woke up around 0245 hours, the lights were on in his room and his clothes were thrown all over the room. Brandon advised it looks like she just looked through all his stuff. Brandon advised he confronted Morgan about the condition of his room and he said she was "wasted drunk." After confronting her, she started to get violent, throwing stuff around his room, then went into her room and did the same thing. Brandon advised Morgan punched him in the face three times. I observed Brandon's face on his left side, and it was a little swollen by his eye. He advised after she punched him, he grabbed her by her arms and brought her to her bed. He stated he would not hurt her was just holding her down, so she does not hurt him. Brandon advised Morgan then ran out of the house and tried to hide in the bushes. He stated he found her and was able to bring her back to the residence. After bringing her back to the residence, Morgan ran out the front door again.

I then spoke with Rene, and she advised Morgan was out most of the day drinking. Morgan came back home started verbally arguing with Brandon. At approximately 0000 hours Morgan was awake, dressed and left the residence. Rene advised Morgan came back home at approximately 0245 hours and went upstairs. Rene advised Morgan was going through Brandon's room. Rene advised that Brandon said to Morgan to get out of his room, so she went into hers and trashed it. Rene stated she was yelling and screaming. Rene advised she saw Morgan was trying to hit Brandon. Rene advised Morgan was getting real violent. Rene said to Morgan to calm down, and this was when Morgan started to break things in the residence.

I walked back to my vehicle and advised Morgan that she was being placed under arrest for domestic battery. While at Jupiter Medical Center for medical clearance for Morgan, I read Morgan her Miranda Warnings from a pre-printed card. Morgan advised she understood her rights. She was asked what happened tonight; she advised that things got physical between her and Brandon. Morgan stated Brandon told her that she was not allowed to go back out to the bars. She advised that she does not like when people tell her no, and she started to punch Brandon in the face.
