Upon my arrival I spoke with Mst. Rohima Khatun Tinni, (B/F, 03/24/94), who was visibly upset. Ms. Tinni was crying uncontrollably and it was very hard to understand what she was trying to say. Note: Ms. Tinni is new to the US Country as of December 2017, she speaks Bangla from Bangladesh. A friend Ms. Pamela Khan, (B/F, 10/08/91) arrived on scene to assist in translation.</p> <p>Ms. Khan states that Ms. Tinni and her husband, Muhammad H. Islam, (B/M 03/19/1990) got into a verbal argument about their financial situation. Ms. Tinni stated they began insulting each others families. Ms. Tinni and Mr. Islam's verbal argument escalated into a physical dispute. Ms. Tinni pushed Mr. Islam in the chest. Mr. Islam punched Ms. Tinni on the left side of her head two times. Ms. Tinni denied seeking any medical attention.</p> <p>Mr. Islam was read his Miranda Rights. Mr. Islam confirmed he and his wife Ms. Tinni were in a verbal argument that escalated into a physical dispute. Mr. Islam stated he did punch his wife in the head twice. Mr. Islam stated the dispute was over family matters and it is becoming stressful.</p> <p>I took photographs of Ms. Tinni and uploaded them into Arbitrator.</p>
