

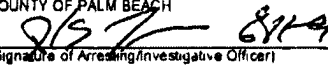

On the above date and time, I responded to 15050 S. Jog Rd. unincorporated Delray Beach, FL. in reference to a retail theft at the business of Home Depot. Upon arrival contact was made with loss prevention who completed a sworn written statement indicating, "I observed a Subject now identified as Myron Fonseca as per FL DL he provided via phone pic entered into the building with an empty cart at approx. 3:00pm, my attention was drawn to Fonseca when I observed him enter into electrical dept. and immediately selected brand new hot item (Gen Tek wireless headset) just hit the sale floor so I decided to maintain observation. During observation Fonseca was observed selecting several items from electrical to garden items and several other dept., while maintaining observation I Followed Fonseca as he proceeded to garden dept. where he was observed spreading items out flat along the bottom of the cart and within a few seconds later, Fonseca selected two bags of mulch and placed the two large bags nice and neatly on top of \$132.26 worth of merchandise and proceeded directly to front end. Once Fonseca reached the front end he was observed handing items to a cashier that was nearby, but failed to notify the cashier about the \$132.26 of merchandise concealed under the mulch bags. Fonseca finalized his purchase and passed all points of sale failing to render payment for the \$132.26 worth of concealed merchandise under the mulch bags. At that point I made my approach and spoke with Fonseca about all the items he had just concealed under the mulch bags, Fonseca was then escorted to the back where all of his information was obtained and PBSO was notified immediately. Fonseca was released to Officer T. Graham." Based on the above investigation Myron, is found to be in violation of F.S.S. 812.014.3.A retail theft.
