BRPD dispatch received a call from a driver advising that a silver Corolla was swerving in and out of lanes as the vehicle travelled southbound on N Federal Hwy. The witness also advised that the Corolla ran over a curb and stopped at the light at by Denny's 3200 N Federal Hwy and not moving. The witness thought that the driver might be passed out behind the wheel. Ofc Torsiello then got behind the Corolla bearing Fl tag#Y08VZT and activated his lights and advised that the driver appeared to be passed out behind the wheel. Ofc Torsiello advised that as soon as he got out of his marked unit the vehicle started to drive southbound. Ofc Torsiello advised he then got back in his vehicle and was able to get the vehicle to stop at 2800 N Federal Hwy. Ofc Torsiello then contacted the driver Natalie Shirm and advised that she had an odor of an alcoholic beverage emanating from her person. Ofc Mcquiston was also on scene.</p> <p>I then met with Shirm and asked her to exit the vehicle and walked her over to the front of my vehicle. I then asked Shirm where she was coming from and she stated that she didn't know. She stated that she didn't know where she was at and only that she was trying to get to her boyfriend's house on 45th and Military Trl. I asked Shirm if she had been drinking and she stated yes.</p> <p>Based on my observations I asked Shirm if she would submit to roadside sobriety tasks to dispel my alarm that she was under the influence. Shirm advised that she would submit to roadside tasks. I then walked her over to a well-lit area and asked her if she had any medical problems or medical issues that would prevent her from doing the tasks. Shirm advised that she is bi-polar and schizophrenic and takes medication for that. The tasks that were conducted were the Walk and Turn, One Leg Stand, Finger to Nose, and the Rhomberg Alphabet.</p> <p>The first SFST was the Walk and Turn. Shirm started the task and took 10 steps</p>

forward and 11 steps back. She was swaying during the task and failed to keep her feet heel to toe. She failed to count each step as instructed to do so. She also made an improper turn by just turning around instead of the way that she was instructed. She also failed to keep her hands to her sides as instructed instead she placed her hands up like an airplane.


The second SFST was the One Leg Stand. Shirm put her foot down during the task and she was swaying during the task. Shirm switched foot from her left foot to her right foot and still was unable to do the task. Shirm didn't count during the task and held her hand out like an airplane for balance.

The third SFST was the Finger to Nose (L-R-L-R-L). Shirm on the first left, first right and second left kept her finger on her nose. On the second right she touched her right nostril. On the third right she brought her left hand up and touched her nose. On the third left she touched under her nose. She also swayed during the task and also opened her eyes during the task.

The fourth SFST was the Rhomberg Alphabet which she recited properly. Based on my investigation I placed Shirm under arrest for DUI. Ofc Coon searched Shirm and I then transported her to BRPD.

Ofc Rafalko responded as my Breath Test operator. Ofc Rafalko and I conducted the 20-minute observation and then she was taken into the BAT room. Shirm advised she wouldn't provide a breath sample. I then read her Implied Consent Warnings and she advised that she wouldn't provide a sample. I also read Shirm her Constitutional Warnings which she advised she understood and she wouldn't answer my questions without an attorney present. See DUI influence report.

Shirm is being charged under F.S.S. 316.193(1) for DUI. Shirm was transported to Palm Beach county jail for final disposition. Shirm's vehicle was towed to Westway.
