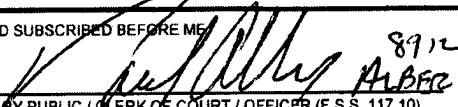

I, Ofc. Bigtree #0072, was conducting uniformed patrol for the Town of Palm Beach Police Department, assigned as unit 105. While on patrol, I was wearing Palm Beach Police class "B" uniforms with city patches on each sleeve, duty belt including issued firearm, and outer vest with my department issued police badge and name plate prominently displayed on the chest. This uniform is consistent with that of law enforcement officers around the country and makes me readily identifiable as such. I made contact with the defendant at the intersection of Royal Palm Way/S. Ocean Blvd. At the time of our contact, Smith and another unidentified female walked off the beach and got into a black Mercedes 4D bearing Florida tag: JJ9NM. Myself and Ofc. Morine were standing directly next to the passenger side doors of the vehicle. Smith entered the driver's seat and the unidentified female entered the front passenger seat. When Smith and the unidentified female opened the car doors, I immediately noticed a strong smell of marijuana emanating from inside the vehicle. Ofc. Morine and I knocked on the front passenger window. When the passenger rolled down the window, I again noticed a strong smell of marijuana emanating from the vehicle. When informed of the smell, Smith stated "it's my mom's car, I just have wraps in here." I gave a lawful command for Smith and the passenger to step out of the vehicle. At that time, Smith rolled up the windows, put the vehicle in drive, and fled at a high rate of speed westbound on Royal Palm Way. I returned to my patrol vehicle and activated my emergency lights and proceeded westbound on Royal Palm Way. My department issued patrol vehicle is emblazoned with "Palm Beach Police" on each side and permanently affixed red and blue emergency lights. I observed the suspect vehicle swerving in and out of traffic at a high rate of speed, driving extremely recklessly. The vehicle continued westbound over the Royal Palm Bridge at a high rate of speed. Palm Beach Police Dispatch sent a Be on the Look Out (BOLO) to West Palm Beach Police Department (WPBPD). WPBPD advised that vehicle was just involved in a hit and run at the intersection of Okeechobee Blvd./ Dixie Highway, approximately one mile west of the Royal Palm Bridge, where the vehicle was last observed. Based on the above facts, probable cause exists to charge Natasha Smith with Fleeing and eluding pursuant to F.S.S. 316.1935(1), Resisting Without Violence pursuant to F.S.S. 843.02, Reckless driving pursuant to F.S.S. 316.192(1)(a), and Driving While License Suspended with knowledge pursuant to F.S.S. 322.34(2)(a).
