
I responded to 5183 45th St in unincorporated WPB FL, in reference to a domestic in progress. Upon my arrival I met with the irate complainant/suspect, Natasha Fritz. Irate Natasha began screaming to arrest both her mother, the victim Donna Durham and her brother Geoffrey Durham for theft. Natasha stated "both of them stole my pills" I attempted to gain more details to the incident made Natasha upset. Natasha walked away and began screaming at everyone on scene.

I then met with the frightened Donna Durham. Donna stated she has been dealing with Natasha and her drug addiction for several years. Sometime ago Natasha began recovery but recently she began using drugs. Donna has not seen Natasha physically abuse drugs but her attitude and abuse of her prescribed medication indicates further drug abuse. Donna further stated for the past few days Natasha has been arguing over missing Xanax. Donna could not advise what the Xanax were for but stated Natasha is prescribed that medication. Moments later Natasha again irate and alleging her mother of theft interrupted my investigation.

I then met with witness, brother Geoffrey Durham. Geoffrey stated he never touched or took any of Natasha's property. Geoffrey further confirmed Natasha's drug addiction and aggressive behavior. While speaking with both Geoffrey and Donna, Natasha walked out with Donna's Iphone 6 valued at \$700.

Donna demanded her phone back from Natasha three times in my presence. Natasha refused and proceeded to scream the phone belonged to her daughter and refused to return it to Donna. I then ordered Natasha to return the phone to Donna and she refused. Natasha then attempted to run back in the home with the phone in her hand after acknowledging my lawful command.

Based on my observation I find probable cause to arrest the suspect Natasha Fritz for violation of FSS:812.014(1) and (2)(c) GRAND THEFT did knowingly obtain or use, or endeavor to obtain or use * (PROPERTY TAKEN) of a value of \$300.00 or more, which was the property of *(VICTIM), or any other person not the defendant(s), with the intent to permanently or temporarily deprive *(VICTIM) or any other person not the defendant(s) of the property.
