

front of the residence. Almost immediately, I observed redness on his chin and with a closer look there were three scratch marks with a little bit of blood. Jason advised he was punch in the face by his wife Natasha Dickenson (W/F, 11/23/81).

Jason advised he and Natasha are currently going through a divorce. Natasha is currently in the process of moving out of the residence. Jason and Natasha currently sleep in separate bedrooms. Jason stated he and Natasha have an agreement between one another that their son Nathan Dickenson (w/m 12/2/13) switches off and on who's bedroom he sleeps in. Tonight was Jason's night for Nathan to sleep in his room. Jason stated Nathan was in his room tonight and he was attempting to put Nathan to sleep. Nathan wouldn't go to sleep and was jumping around the bed. While Nathan was jumping on the bed, he ended up jumping on Jason and hurting his neck. Nathan began to cry and Natasha came into the bedroom and grabbed Nathan. Jason followed Natasha out of the bedroom because it was his night for him to have Nathan. Jason stated Natasha began to yell at him, so he began to yell back. In the process of the argument Jason advised Natasha was holding Nathan in her arms asking Nathan "Did daddy punch you in the neck?". Jason told Natasha he fell on top of him when he was jumping on the bed. Jason began to yell at Natasha and while yelling at her saliva came out of his mouth because he is currently suffering from a cold. Jason believes Natasha took that as he was intentionally spitting on her so she struck him in the chin with her fingers causing an abrasion to his lower chin.

After speaking with Jason, I spoke with Natasha and she advised the following: Natasha advised while she was in her separate bedroom she heard Nathan crying from Jason room. She immediately got up and went to see what had happened. Natasha stated she grabbed Nathan and took him out of the room and into the hallway. While in the hallway, she stated Nathan told her "Daddy punched me in the neck" and she asked him again and again "What did daddy do?". Natasha stated Jason then began to yell at her because she grabbed the child. In the process of yelling at her Jason "rolled up his tongue" and intentionally spit in her face. After spitting in her face she began to yell back pointing her finger in his face, Natasha advised Jason intentionally threw his chin into her finger and yelled "you just assaulted me" and called the police.

I went back outside and spoke with Jason some more and Ofc. Schneider was inside speaking with Natasha. #330. Ofc. Schneider #330 advised me, Natahsa is now stating it is possible Jason saliva came out of Jason's mouth when he was yelling because of the cold. I went back inside and spoke with Natasha once again because her story kept changing. Natasha then began to say, she did not touch him and that he self-inflicted the marks on his chin so that she would get arrested.

Natasha did not have any evidence to show that Jason intentionally spit on her. Jason was the only one to have physical injuries. Natasha changed her story about the spitting multiple times. During my initial encounter Natasha advised Jason rolled up his tongue and intentionally spit in her face. The second encounter she advised spit came out of his mouth because he was yelling at her and the third time she reverted back to saying he intentionally hocked a ball of spit and spit it directly in her. Due to the multiple stories she told me, I found Natasha to be the primary aggressor and found probable cause to charge her with simple battery (domestic). I placed Natasha into handcuffs, checked for spacing, and double-locked for safety. Natasha was placed in the back of my fully marked patrol vehicle.

Based on my above-described investigation, Natsha did actually and intentionally strike Jason against his will contrary to Florida Statute 784.03(1) (A) (1)


I issued Jason a Domestic Violence Brochure. Photos were taken of Jason's injuries and they were submitted

I contacted the Department Child and Families Service in reference to the child Nathan being involved with the altercation. I spoke with DCF employee Marsha ID 229.


