Probable Cause

On June 3, 2018 I was on routine patrol in my marked patrol car in Palm Beach County. I was traveling northbound on I-95 (State Road 9) north of 10th Ave N. I observed a grey 4 door vehicle exit a business parking lot and striking the curb/sidewalk when exiting the lot. I continued to follow the vehicle and observed that the vehicle was failing to maintain a single lane. The vehicle was swerving within lane and crossing the lane divider on the right side of the lane. I then activated my emergency lights and sirens to initiate a traffic stop on the vehicle. The vehicle yielded into the parking lot of Canal 8 road and Military Trail. I approached the driver side of the vehicle and identified myself. I then requested that the driver present a DL, vehicle registration and proof of insurance. I observed that the driver was the sole occupant of the vehicle. While I talked to the driver I observed that there was an odor of an unknown alcoholic substance emitting from her breath as she talked. I also observed that she had bloodshot glassy eyes and slurred speech. I then requested that the driver step out of the vehicle and she agreed. As she walked towards my patrol car I observed that she had an orbital sway and used the car for balance. As she stood in front of me I again observed the odor of an unknown alcoholic beverage emitting from her

breath as she talked. I also observed the orbital sway and the blood shot glassy eyes. I then requested that she conduct field sobriety exercises and she agreed. The driver was later identified as Natasha Navarro by her FL DL.

Horizontal Gaze Nystagmus

Before beginning the exercises, I checked to see if Ms. Navarro was wearing glasses or contact lenses. It was determined that Ms. Navarro was not wearing glasses or contacts. I then checked her eyes and observed equal tracking and equal pupil size. She was instructed to place her feet together and place her hands down at her side. She then was instructed to keep her head still and follow the stimulus with her eyes and her eyes only. She was also instructed to keep looking at the stimulus until told not to. She verbally indicated that she understood. During the exercise I observed 6 of the 6 possible clues.

- Lack of smooth pursuit, left eye
- Lack of smooth pursuit, right eye
- A distinct and sustained nystagmus at maximum deviation in the left eye
- A distinct and sustained nystagmus at maximum deviation in the right eye
- An onset of nystagmus prior to 45 degrees in the left eye
- An onset of nystagmus prior to 45 degrees in the right eye

I observed vertical nystagmus.

During the exercise Ms. Navarro had to be told to stay in the proper position and not to move her head during the exercise. She tried to anticipate the position of the stimulus. I also observed Ms. Navarro to have orbital sway. I again observed the odor of an unknown alcoholic substance emitting from her breath.

Walk and Turn Exercise

The area was level and free of debris. Ms. Navarro indicated that she observed the white line on the ground. Ms. Navarro was instructed to put her left foot on the line, then place her right foot on the line ahead of the left foot in a heel to toe manner. I then demonstrated this position. She was instructed not to begin untold to do so. Ms. Navarro verbally indicated that she has understood all instructions up to this point. Ms. Navarro was then instructed to take 9 heel to toe steps on the line when told to do so. I then demonstrated this. Ms. Navarro was then instructed to turn on the ninth step and to keep the front foot on the line and to take a series of small steps with the foot on the line. I then demonstrated this.

While explaining the exercise Ms. Navarro stated that she did not want to continue to conduct the exercises. I then explained to her the consequences and that refusing to do the exercises can be used in court as evidence against her. She stated that she understood and refused again. She was then placed into handcuffs and under arrest for DUI. She was then secured inside of my patrol car and transported to the county jail. Once I arrived at the testing center I conducted a 20 minute observation of Ms. Navarro. At no time did she regurgitate or take anything by mouth. I then requested that she submit to a lawful test of her breath and she refused. Implied consent was read and she stated that she understood. She then refused again. She was then booked into the Palm Beach County Jail.

The above incident occurred in Palm Beach.


