On September 1, 2016 Palm Beach County Animal Care and Control (PBCACC) received a call from the defendant Navin Ramgopaul stating that he had a stray dog confined in his laundry room for pickup.

On September 2, 2016 Animal Control Officer (ACO) C. Cook #2133 arrived at 6382 Pinestead Drive, Apt. 1615, Lake Worth and met with Navin Ramgopaul. ACO Cook requested that Navin Ramgopaul bring the dog outside for him to view. ACO Cook observed a male white and brown English Bulldog. The dog appeared active but emaciated. Navin Ramgopaul then stated to ACO Cook that he had been dishonest about the fact that the dog was a stray and that actually he had the dog for three months. He claimed to have gotten the dog from someone in Kendall, Florida off a Craigslist posting. Navin Ramgopaul did not have the information for the owners in Kendall. Navin Ramgopaul then stated that shortly after obtaining the dog his girlfriend Krista Napoletano took the dog to Palm Beach Veterinary Specialists for a checkup as the dog's penis was red and swollen. Navin Ramgopaul stated that the veterinarian had told his girlfriend that the dog self mutilates itself. He was not sure if they had provided any further care for the dog at that time. Navin Ramgopaul also stated that the dog was not as thin as it was now but that he feeds the dog two to three times a day and that the dog does not seem to gain weight. Navin Ramgopaul stated that he decided to contact PBCACC claiming that the dog was a stray as he was unable to afford veterinary care and did not want to be judged for the dog's appearance.

ACO Cook then took photographs of the dog. ACO Cook also observed that the defendant had dog food in a bin. Navin Ramgopaul stated to ACO Cook that the dog was also incontinent and leaked urine constantly. ACO Cook observed the dog's penis to be red and inflamed and that the dog was leaking urine from its penis. Navin Ramgopaul then read and signed an owner surrender form. ACO Cook then impounded the dog to be taken to PBCACC.

On September 3, 2016 staff veterinarian Dr. L. Kishon examined the English Bulldog named Frankie. Dr. Kishon stated that Frankie was emaciated scoring a 5 on the Tufts Animal Care and Conditioning scale (1 being ideal and 5 emaciated).

Dr. Kishon found:

SUMMARY: This dog was suffering from severe starvation.

MANNER OF INJURY: Lack of basic care, like proper and sufficient quality food and water; lack of caring of minimal hygiene.

CONCLUSION: This dog was suffering from starvation. Starvation can cause organ damage and eventual organ failure which can lead to death; this can be a long and painful process. He was not suffering from lack of appetite; he ate and drank well with us. Withholding proper and sufficient food from an animal constitutes animal cruelty

On September 8, 2016 I placed a call Navin Ramgopaul for more information regarding his dog that was owner surrendered to Animal Control. I made contact with him and asked how long he had owned the dog Frankie as he had told ACO Cook he had obtained the dog three months prior. He stated that he actually had the dog for about a year. I asked him if he had taken Frankie to the veterinarian at any time within that year. He stated he did take him to Best Friends Animal Clinic for an initial visit when he obtained the dog and also a second time because the dog was self mutilating his penis. He stated that was over nine months ago that he had taken Frankie to the veterinarian and that they told him to go immediately to Palm Beach Vet Specialists. Once there they kept Frankie overnight and stated that the he would need surgery. He stated that due to financial constraints they never followed through with the surgery. I asked when he noticed that Frankie was losing weight and he stated in the beginning of the year around January 2016. He stated that they tried all kinds of different foods like puppy food and high calorie foods but it did not help. I asked where he kept Frankie and he stated that he was kept indoors and that he had two crates as he had another dog at home a female English Bulldog who was fine. I requested that he contact his veterinarians and have them email me copies of Frankie's records to review. He stated he would contact them. He asked how Frankie was doing and I advised that our medical staff was treating him. A few minutes later Mr. Ramgopaul contacted me back to state he called his veterinarians and that they would be providing me the records via email.

As of today I have not received any veterinary paperwork showing that Frankie was every treated for any of his ailments.

Navin Ramgopaul failed to act by not providing Frankie with veterinary care for more than nine months, which caused pain and suffering. He contacted PBCACC and falsely claimed that Frankie was a stray to avoid having to pay any fees or obtain vet care due to the way Frankie looked. Frankie had a strong odor of urine and his nails were overgrown due to neglect. Frankie weighed just 24 pounds when he was brought to PBCACC and was adopted by a rescue at 48 pounds approximately one month later. PBCACC provided basic medical care, food, water and shelter for Frankie. Based on the above facts probable cause exists to charge Navin Ramgopaul with two counts of animal cruelty, F.S.S. 828.12,2 and 828.13.
