<p>On the <b>20th</b> day of <b>December</b> <b>20 16</b> at <b>2318</b> <input type="checkbox"/> A.M. <input checked="" type="checkbox"/> P.M. (Specifically include facts constituting cause for arrest.)</p> <p>On Monday 12/19/16 around 2318 hours, I was on routine patrol in the Village of Royal Palm Beach, Palm Beach County, Florida. I was in the eastbound U-turn lane near Al Packer Ford, when I saw a vehicle approaching at high speed from the rear. I activated my rear radar and got a reading of 89 MPH. INV Schaefer also got a reading of 86 MPH on his radar. As the car passed me, I identified it as a new model white Chevy Corvette. Maintaining a clear unobstructed view the entire time, I caught up to the defendant's white Chevy Corvette bearing FL tag 361WZZ, and paced it at 78 MPH in a marked 50 MPH zone. I stopped the defendant for speeding in the 11000 block of SR80. (All speeds were determined by visual estimation and confirmed by proper pacing technique using PBSO pace car asset #70103 / VIN# 1FAHP2MK8FG119488, which was properly calibrated and certified at the time).</p> <p>When I activated my lights and siren, the defendant braked hard, nearly causing me to rear end his vehicle. He then turned approximately 90 degrees and moved abruptly from the left most lane, to the right most lane, nearly causing another crash with a different vehicle.</p> <p>I made contact with the defendant, later identified by FL DL as, Neal Ganon. I observed that the defendant had glassy watery eyes with fully dilated pupils, slurred speech, profuse sweating on a cool night, a "distant" gaze, and he fumbled with his paperwork. I asked how much he had had to drink. He said, "nothing tonight."</p> <p>I asked the defendant to exit the vehicle. The defendant swayed while standing, stumbled while walking, and leaned on the car for balance. He moved in a very slow deliberate manner, but was also spastic, trembling, shaking profusely, and swaying so badly that I expected him to fall down at any second.</p> <p>I conducted the penlight task. On the penlight task, I saw no resting nystagmus, equal pupil size, and equal tracking. The defendant had all 6 clues of impairment, swayed and trembled throughout the task, failed to follow and anticipated the stimulus, and moved his head. he was VGN - and LOC +. His nystagmus was unusual in that it was not distinctly side to side or up and down. He had no resting nystagmus, but when he tried to follow the stimulus, his eyes jerked and bounced erratically and randomly in all directions. I had INV Schaefer repeat the task for his training and experience. Schaefer confirmed what I had seen.</p> <p>I asked the defendant why he was so nervous. He said, "8 years ago, in this very spot, I was under the exact same circumstances, and I had consequences." I asked if he was arrested. He said yes. I asked if he was arrested for DUI. He said no. I asked if he had been arrested for just the speeding. He said yes. He then said that he was arrested for DUI. I asked "right here? In Palm Beach County?" He, eventually, said "No, that was on the Turnpike in Stuart." I did not find any history of DUI in DAVID.</p> <p>I asked the defendant if he had any medical problems, including diabetes or epilepsy. He said he was diagnosed with "vertigo" about seven years ago. He asked if he could "do this without my boots? I told him yes. He sat down on the curb and asked if he could, "do anything without my legs because I'm shaking so badly?" I instructed him to stay seated for his safety, and I skipped the walk and turn and one leg stand for his safety. I conducted the remaining tasks with the following results...</p> <p>On the finger to nose, after stating that he understood the instructions, the defendant failed to keep his eyes closed and head back, failed to return his hands to his sides multiple times, and hesitated, searched, and missed tip of finger and or tip of nose multiple times. On every attempt, the defendant would bring his finger to within about 4 or 5 inches of his face, open his eyes to visually acquire the finger, and then try to touch his nose, missing every single time.</p> <p>On the Palm Pat, the defendant failed to maintain the instructional stance, started before being told, and "copied me", after my instructions to, "stay like that until I tell you." After stating that he understood the instructions, the defendant failed to count out loud as instructed, opened his hands like a book, double patted and chopped, and failed to increase speed as instructed.</p> <p>On the hand coordination ask, the defendant actually did fairly well.</p> <p>On the Rhombert alphabet, he swayed throughout the task, and recited the alphabet to T before misstating it "Q,R,S,T,Z."</p> <p>Based on my training and experience, and the totality of the circumstances, I handcuffed the defendant, checking them for fit and double lock, searched him incident to arrest, explained that he was under arrest for DUI, and transported him to the BAT without incident. At the BAT, the defendant consented to breath and was found to have BAC of .000. Because his impairment was inconsistent with this BAC, I requested a sample of his urine to test for chemical and or controlled substances. He consented. I read Implied Consent, in case he changed his mind. He answered the Q&amp;A, but denied any alcohol or illegal drugs. He said he takes multiple medications, but took them last yesterday morning.</p> <p>We finished the BAT video at 0102. At approximately 0330, he provided a urine sample, which I submitted to the PBSO crime lab for analysis. The defendant signed all his paperwork and was booked in to the main detention center without incident.</p>
