On the 24 day of February, 2017 at 01:22 (Specifically include facts constituting cause for arrest.)

On Friday, February 24, 2017 at about 12:50am, I responded to 184 Timberwalk Trl. in reference to a report of a suspicious person. The caller, W/F Cristina Picon (12-6-65) stated there was a black male wearing a blue and white shirt outside of her door who she did not know. Cristina said she was locking herself inside the bathroom until police arrival. Cristina said she heard someone try to force open the front door.

Upon arrival, I noticed a taxi cab parked in front of the residence and a black male matching Cristina's description outside and on his cell phone. The male was the driver of the cab, and he was on the phone with Northcomm Communications. Next to the front driveway I noticed a male, later identified as W/M Nelson Picon (10-18-63) lying in the grass next to a tree. The taxi driver said he had brought Nelson to his residence from Rachel's Gentleman's Club in West Palm Beach. Nelson had exited the cab and fell to the ground where I found him.

I walked up to Nelson on the ground and woke him up. Nelson was clearly very intoxicated, sat up, but continued to sit on the ground. I noticed two small scrapes on the left side of his neck.

Cristina came to the front door and payed the cab fare. The taxi driver then left the area. Cristina entered her residence, saying she did not want Nelson inside the house in his condition.

Officer Lopez (325) and I told Nelson he should walk to the back patio and go to sleep. Nelson was belligerent, continually saying "fuck you"! and "I don't have to listen to you"! Ofc. Lopez and I left Nelson by the front door, and walked around the corner out of his sight.
