On 11/10/2019 at 0242 hours I was patrolling the parking lot of McDonald's restaurant at 6760 West Indiantown Road, Jupiter FL 33458 in my marked patrol vehicle, wearing full Jupiter Police Uniform.

While driving on the south side of the parking lot, I observed a naked H/F squatting up against the building, urinating near the east entrance doors to the restaurant. The female's shirt was off and her breasts were exposed. Her pants and underwear were down as well. Other McDonald's patrons and passerby's were in the area, as the McDonald's is located next to a hotel.

I also noticed that there was a gray sedan (FL tag 611QHQ) in the drive through line of the McDonalds, with the front passenger side door wide open.

I made contact with the H/F who was urinating in public, and instructed her to put her clothing back on.

I learned that the H/F was riding in the gray vehicle in the drive through line prior to exiting and urinating near the entrance to the restaurant. The H/F driver of the gray vehicle confirmed that it was her friend, and she drove the car into a parking space.

The H/F who was urinating identified herself as "Jessica". When I asked for the rest of her name, she told me that "Jessica" was the entirety of her given name, and that she didn't have a last name.

I spoke to her in simple Spanish and English, to which she pretended she did not understand. She later told me that her full name was Jessica Rodriguez, and her date of birth was 4/10/88. Upon checking the name is FCIC/NCIC, no record was found.

Spanish speaking Officer Tappin arrived on scene and spoke to "Jessica" in fluent Spanish. She then informed him that her name was actually "Leslie Morajas (4/26/1988)", and she was scared to tell law enforcement her real name because she is an illegal alien.

I then spoke with the driver of the gray sedan, who identified herself via Mexico ID card as H/F Madel Rosario Diaz Ortega (1/17/1973). Upon checking her information in FCIC/NCIC, I learned that she did not have a driver's license and had a past of driving without a license.

Ortega told me that her friend's last name was actually "Garcia" and that her identification card was in the vehicle. Ortega was instructed to exit the vehicle, and she told me I may retrieve the identification card from her vehicle.

I located the Mexico ID card in a black purse on the front passenger seat. The name on the card was "Nesly Garcia Monjaras (4/26/88)". The picture on the ID card matched the H/F who was urinating in public. I showed her the ID card and she confirmed it was her's, and again reiterated that she was scared to give her real name to law enforcement.

Monjaras and Ortega were both advised they were under arrest. They were placed into handcuffs which were checked for proper spacing and double locked. Officer Newman of the North Palm Beach Police Dept. searched both arrestees with negative results for contraband.

Ortega's vehicle was towed from the scene by All Hooked Up Towing.

Based upon the above aforementioned facts I find probable cause to charge Nesly Garcia Monjaras (4/26/88) with Florida Statute 901.36(1) GIVING FALSE NAME UPON BEING ARRESTED OR DETAINED, and Florida Statute

I Find probable cause to charge Rosario Diaz Ortega Madel with Florida Statute 322.34(2)(a) DRIVE WHILE D/L CANCELED, SUSPENDED OR REVOKED, as she has previously been charged for driving without a license, knew that she could not drive, and stated that she had a pending court date on 11/13/2019 for driving without a license.

Body worn camera was used for the duration of this incident. The above listed events are a summary of the body worn camera footage, and are not purported to be verbatim.

Ortega and Monjaras were transported to the Jupiter Police Dept. for processing, and then to the Palm Beach County Jail without incident.
