The defendant appeared to be intoxicated and was bothering customers at the location. The subject approached a female, who appeared to be with another male, and began to place his hands on her arms. When another male intervened, the defendant attempted to start a fight. I then asked the defendant to leave, which he complied and went outside.</p> <p>While outside, the defendant attempted to start fights with other persons at the location. Per FSS 856.011(1), no person in the state shall be intoxicated and endanger the safety of another person or property, and no person in the state shall be intoxicated or drink any alcoholic beverage in a public place or in or upon any public conveyance and cause a public disturbance. This incident was in the presence of Eric Gaeta (victim/bartender).</p> <p>Based upon the above information, the defendant is charged with Disorderly Intoxication Per FSS 856.011(1). The defendant was arrested and transported to the Palm Beach County Jail.</p>
