1. Defendant's Petition to Expunge Criminal History Record is granted.

copy of the instant order to any other agency to which the Florida Atlantic University Police Department disseminated the criminal history record information to which this order pertains.



4. All costs of certified copies involved herein shall be borne by the defendant/petitioner.
