P R O B A B L E C A U S E	On 06/03/2018 at approximately 2002 hours I was asked to respond to 850 N US Highway 1 (Burt Reynolds Park East) in reference to a traffic accident involving two automobiles and one motorcycle that occurred at around 1933 hours. I read in the call notes that the driver of the motorcycle, later identified as Gregory A Yate (W/M, 03/06/1961), was transported to St Mary's Hospital due to his injuries.							
	I arrived at the scene and observed the vehicles in the intersection. I saw the black Mazda (V1) in the middle of the intersection facing west near the inner most lane of southbound N US Highway 1. I saw a black Nissan (V2) facing south in the inner most lane of southbound N US Highway 1. Directly behind the black Nissan I observed a black motorcycle (V3) lying on the road on its right side.							
	I spoke with Ofc Yochum ID383 who told me the following: V1 was stopped at red flashing emergency traffic, coming from the parking lot of Burt Reynolds Park East. V2 was traveling south in the inside lane on N US Highway 1 approaching the flashing yellow traffic lights of the Burt Reynolds Park intersection. V3 was traveling south on N US Highway 1 directly behind V2. V1 drove into the intersection intending to go south on N US Highway 1. As V2 approached the intersection it began to brake to avoid a collision with V1. V3 made an evasive turn to the left and the right fairing of V3 struck the driver side of the rear bumper. The rider of V3 was ejected from the motorcycle. V3 fell on its right side and slid hitting the rear driver side bumper of V1.							
A D M I N I S T R A T I V E	A witness on scene told Ofc Yochum that she checked on the rider of V3 and he had agonal breathing and no pulse. The witness began CPR until Police Officers arrived on scene. CPR was continued until Fire Rescue arrived. The rider of V3 was transported via ground to St. Mary's Medical Center as a trauma alert and it was determined after his arrival that he suffered a broken jaw, a fractured scapula, and multiple lacerations. I determined this constituted serious bodily injury. Medical staff advised the injuries

<p>sustained to the rider of V3 were non-life threatening.</p> <p>Ofc Yochum stated to me that when he initially made contact with the driver of V1, identified as Nicholas C Armstrong (W/M, 07/18/1988), he observed that Armstrong was slurring his words when he talked and had an odor of an unknown alcoholic substance coming from his breath. Ofc Yochum told me that he saw that Armstrong had bloodshot glassy eyes as well.</p> <p>Ofc Yochum spoke with the passenger of V2, Jennifer Smith, and she was able to point to Armstrong and identify him as the driver of V1.</p> <p>As Ofc Yochum went to interview Armstrong I stood by observing him, he was wearing only board shorts without shirt or shoes. I could see that Armstrong slurred his words as he spoke and saw that he had bloodshot, glassy eyes. I could detect a strong odor of an unknown alcoholic substance coming from Armstrong's breath. Once Ofc Yochum was done speaking with Armstrong I spoke with him. Ofc Yochum told me the driver of V1 was issued a citation for Disregarding a Flashing Traffic Control Signal.</p> <p>I told Armstrong that the crash investigation had ended and I was now starting a DUI investigation. I read Armstrong his Miranda Warnings. I asked Armstrong how much he had to drink tonight; he replied none and then immediately asked to speak with his attorney. I told Armstrong that I wanted him to complete some roadside tasks that would help me judge his level of impairment. Armstrong again said that he wanted his attorney. I explained to Armstrong his Taylor Warnings and asked him again if he was willing to complete the roadside tasks. Armstrong stated that he wanted to speak with his attorney. Due to the totality of my investigation I placed Armstrong under arrest for DUI and during the course of driving a vehicle while under the influence of alcoholic beverages, or chemical substances as set forth in F.S. 877.111, or any substance controlled under Chapter 893 or any combination thereof, did cause or contribute to the cause of serious bodily injury to Gregory A Yate, contrary to Florida Statute 316.193(3) (a), (b). At approximately 2049 hours, I put Armstrong in handcuffs checking for proper spacing and double locking them. I put Armstrong in the backseat of my police vehicle.</p> <p>I then transported Armstrong to the Palm Beach County Breath Alcohol Testing Facility. I conducted a 20 minute observation period to ensure that Armstrong did not take anything by mouth or regurgitate. I then requested Armstrong provide a sample of his breath. He refused. I informed Armstrong of Implied Consent and asked him again to provide a sample of his breath. Armstrong refused again. I read Armstrong his Miranda Rights from a prepared text. Armstrong invoked his rights.</p>

A DHSMV check of Armstrong's driving history revealed that he had a prior suspension for refusal to submit to a breath, urine or blood test. Armstrong also currently has a business only restriction on his driver license.

At 2217 hours, I received a phone call from Ofc Borrows ID380. Officer Borrows is an experienced DUI Investigator and had just come on duty. Ofc Borrow informed me that because the victim of the crash sustained serious bodily injury, a blood sample should be obtained. I transported Armstrong to the Jupiter Medical Center. Upon arrival at approximately 2249 hours, I was met by Ofc Borrows and Ofc Yochum. Ofc Borrows asked Armstrong to provide a sample of his blood to determine the alcohol content and/or presence of chemical substances. Armstrong refused. Due to exigent circumstances, the time that had lapsed since the initial incident and the fact that the evidence could be lost if any more time passes, Armstrong's blood was drawn without a warrant at approximately 2258 hours. Ofc Borrows told Armstrong that his blood would be drawn even though he refused. Ofc Borrows asked Armstrong if he would cooperate while his blood was being drawn so force would not be necessary. Armstrong stated that he would cooperate. RN Erik Wong was able to draw two vials of blood from Armstrong without incident. Ofc Yochum maintained possession of Blood and placed it into Jupiter PD evidence.

Once Armstrong was cleared by JMC medical personnel I transported him to Jupiter PD to complete my paperwork. Armstrong was then transported to the Palm Beach County Jail where he was subsequently booked for DUI, refusal to submit to a lawful breath test, and violating the "Business purpose only" restriction on his driver license.




