Narrative:

I responded to 1811 Renaissance Commons Blvd. #2515, Boynton Beach, FL, 33426, in reference to a Domestic Violence call.

BBPD Communications (Dispatch) advised the caller later identified as W/F Marcela Montoya (DOB 11/6/78) advised her live in boyfriend W/M Nicholas Krikorian (DOB 2/1/83) hit her in the face.

Upon arrival I made contact with the victim W/F Marcela Montoya (DOB 11/6/78) identified by MA/DL. Montoya advised the following she has been living with her boyfriend at the above residence for 2 years. They have been dating for over 2 years and have no children in common. Montoya advised they have been packing up to move into a new apartment the last few nights. Montoya advised that they got into an argument tonight because Krikorian wanted \$250 for rent. When Montoya refused to give him the money they began arguing. She then stated she is not going to move into the new apartment with him and began unpacking her things from the boxes in the kitchen. Montoya advised Krikorian became angry that she was going through the packed boxes and grabbed her by her right arm and stated "I'm going to knock you out". Montoya advised in defense she kicked Krikorian off of her because he has hurt her in the past. During the altercation while Montoya was trying to get Krikorian off her at some point he grabbed her right pant leg and ripped her pants. Montoya advised Krikorian then punched her in the lower left chin area of her face. Montoya advised her neighbor then came into the apartment after hearing the commotion and Krikorian left the apartment. Montoya provided me with a sworn statement recorded on my body worn camera between 14:38 mins and 15:40 mins.

I observed redness and swelling on Montoya's lower chin area on her face and swelling to Montoya's lower left lip. Montoya also had a black and blue bruise on the inside of her upper right arm accurate with her statement. I also observed Montoya's right pant leg to be ripped. Let it be known Montoya also had a bruise on her right outer upper arm which she advised Krikorian did when he grabbed her yesterday. Photographs of all injuries were taken. Krikorian advised she did not need medical treatment. Montoya did advise she would contact BBPD if the bruises and swelling worsened the next day. Montoya also advises she may get her jaw checked out the next day and would update BBPD with any other injuries. Montoya advised she will sign a medical release form if she does get checked out.

I then made contact with neighbor and witness W/F Haley Auxier (DOB 1/22/90) identified by FL/DL who advised the following. She lives directly next to both parties and could hear them fighting through the wall. She heard screaming coming from the residence and went over to see if everything was okay. The door was open and she saw Montoya and Krikorian verbally arguing. Montoya told her that Krikorian had hit her. Krikorian advised that he did not hit her and only "blocked her". Auxier advised she observed injuries on Montoya to include redness to her chin, a swollen lip, and ripped pants. Auxier advised she did not observe any injuries on Krikorian. Auxier advised as soon as Montoya began calling the police Krikorian left the apartment. Auxier provided me with a sworn statement recorded on my body worn camera between 25:10 mins and 26:46 mins.

Ofc. Pires (996) then made contact with Krikorian over the phone who advised he left and was down in Delray Beach. Krikorian agreed to meet officers at the Boynton Beach Police Department within a half hour to provide his side of the story. Krikorian never showed up and when officers tried to make contact with Krikorian again over the phone it was found that his phone was turned off.

Montoya was advised to contact police immediately if Krikorian returned to the residence.

Based on the above investigation I find Probable cause to charge the defendant Nicholas Krikorian with one count of Simple Battery (Domestic Violence) according to F.S.S. 784.03(1)(A)(1).


