On Saturday, 08/19/2017 at 2307 hours, I was dispatched to 7443 Thatcher Avenue, within unincorporated Lantana, in Palm Beach County, Florida 33462, in reference to a domestic battery. Prior to my arrival, dispatch told me that the victim, Gabriela Ramirez, locked herself into her bedroom and that her husband, Nicholas Mc Conohan was intoxicated and banging on the doors trying to get into the residence. I was told that Gabriela was crying saying that Nich was going to kill her. Jose was screaming at Gabriela telling her that he was going to "beat her ass" and also said "Im going to blow your head away." Upon my arrival, D/S Alfonso ID#8563 and I went up to the front door of the residence. As D/S Alfonso was checking to see if the front door was locked, which it was, we heard a smash and D/S Gorfido ID#24739 yelling in get down from the backyard of the residence. D/S Alfonso broke the front door in and we both rushed into the home heading towards the master bedroom where the victim and suspect was at. I was behind D/S Alfonso when I saw both D/S Alfonso and D/S Gorfido have their weapons aimed at Nicolas. I placed handcuffs on Nicolas wrists, I noticed a handgun on the dresser with the magazine fully loaded. Gabriela told me that her and her husband were fighting off and on that week. Nicolas was at a friend's house doing work in his attic and was also drinking while he was there. Gabriela said that Jose has increased his amount of cocaine lately and has been very aggressive. Nicolas arrived to the house and when he got out of his vehicle he shot a single shot from his handgun into the ground. Gabriela said when she heard the gunshot she knew it was Nicholas. Gabriela immediately went into her bedroom and locked the door and called PBSO telling dispatch kill her. Gabriela said that Jose started to pound on the front door and then came to the back of the house and banged on the doors and windows trying to get into the residence. Nicolas then went back to the front of the residence and broke a window in the kitchen and crawled through. Nicholas broke into the bedroom door and told Gabriela that he was going to "beat her ass" and that he was going to "bow her head away." Nicholas slapped Gabriela while threatening her and then punched her three times. Nicholas punched Gabriela on the forehead, right side of her neck and then on her mouth. Nicholas told Gabriela to get on the bed which she denied. Nicholas pushed Gabriela onto the bed and pointed the gun to the left side of her head saying he was going to shoot her. Gabriela begged for him not to hurt her and told him she was sorry and to put the gun away. Nicholas pointed the gun to Gabriela's head three different times. Gabriela got up and was then cornered into the left corner of the bedroom with Nicholas standing in front of her not letting her by. Nicholas told me that he was working at his friends house and when he got home he was angry because he

angry because he was locked outside of the residence. Nicholas said he broke the kitchen window to get into the residence and crawled through. He broke the bedroom door open which Gabriela had locked to keep him out. Nicholas said that slapped Gabriela in the mouth for not letting him into the residence. Nicholas then saw D/S Gorfido come through the glass window and he immediately laid down on the ground.

D/S Gorfido placed Nicholas in the rear prisoner compartment of his marked PBSO vehicle, asset # 51240, where he activated the rear in car camera and secured him with a seatbelt. Orozzo transported Nicholas to the Criminal Justice Complex, located at 3228 Gun Club Road, West Palm Beach, Florida 33406, where (he/she) was turned over to corrections staff, without incident.
