<p>In The City Of Riviera Beach, Palm Beach Count, State Of Florida: The following occurred. I was contacted by Riviera Beach Dispatch, in reference to an alleged fight that was in progress. Dispatch advised that a call came in from a citizen who had stated that he had observed a unknown white male assaulting a unknown white female, while engaged in what appeared to be a heated argument.</p> <p>After receiving information from the caller who was identified as Mr. Joseph. Sergeant Barr and I responded to the incident location of 2119 Oakmont Drive and made contact with Christine Arnold Gay (Nicholas mother). Gay immediately when asked said they've been fighting. Gay stated that her son Christopher Arnold and his fiancée Amanda Redford (W/F-5/22/93), were in each others face and engaged in a verbal heated argument inside of the home.</p> <p>Gay stated during the argument, Redford attempted to leave the home and Christopher attempted to make her stay by grabbing her around her upper body by wrapping his arms around her. Gay stated that they both eventually ended up on the roadway outside in front of the home, while continuing to argue.</p> <p>I continued my investigation by speaking to Mr. Joseph again and he advised, while he was located in the Thousand Oaks community children's play ground area with his son. He heard what appeared to be loud screaming. Joseph stated that it was coming from a unknown man and woman.</p>

<p>Joseph stated that he walked around the corner to get a closer look and observed a man and woman in each others face. Joseph stated that the unknown male pushed the unknown woman away from him, and as she approached him again, the unknown male punched her in the face with a closed fist.</p> <p>Joseph stated after she was hit, the unknown woman fell to the ground. Joseph stated that the unknown male then stood over her for a minute, before she got up and appeared to follow him back into the home.</p> <p>Based on my initial investigation, information received from Gay and witness statement from a witness who had observed part of the incident. Christopher was arrested for the charge of Simple Battery Domestic. Gay as well as the victim Redford had refused to cooperate any further.</p> <p>However, when initial contact was made with Arnold and Redford inside of the home, they both were sitting away from each other and appeared to be sweating and breathing very heavily, as if they had been involved in a scuffle.</p> <p>Arnold was transported to the Riviera Beach Police Department to be processed, before being transported to the Palm Beach County Jail for further processing on the charge of Simple Battery Domestic. Due to lack of cooperation from the victim, no photo's could be taken for possible injuries. There were signs of injury.</p>
