On Sunday, February 19th, 2018 at approximately 0120 hours, I responded to 3517 S. Federal Hwy, Boynton Beach, FL in reference to an unconscious person.

Upon arrival, I made contact with W/M Nicholas Milano (DOB10-26-1988) who was currently laying in the roadway near the entrance to Seaborne Cove development. Nicholas was unconscious, but he was breathing and had pulse. I then utilized a sternum rub on Nicholas who then woke up. Nicholas immediately got up and was completely irate. It should be noted that Nicholas' person was emanating a strong odor of an unknown alcoholic beverage. The odor only intensified from Nicholas' breathe as he spoke to me. Robert also had thick, slurred speech, blood shot red eyes, and trouble maintaining his balance. Nicholas began to state that there is *no problem* for him to sleep in the middle of the roadway. After confronting Nicholas of the smell of an unknown alcoholic beverage he got very angry and started to run around causing a public disturbance. Nicholas then stated that he was not drunk and quickly started to sprint-walk on a straight line. Nicholas then ran up on Ofc. Schalk in a very quick manner and out of reaction Ofc. Schalk put his right arm up to create distance between Nicholas. At this time, I approached Nicholas and advised him to put his hands behind his back. While attempting to place Nicholas into handcuffs, Nicholas continued to resist arrest by pulling away. At this time, Ofc. Schalk utilized a straight-arm take-down and brought Nicholas to the ground to gain compliance. Nicholas was then detained (Handcuffed D/L) after a brief struggle on the ground.

Due to the above facts, I find probable cause to charge W/M Nicholas Milano (DOB10-26-1988) with Disorderly intoxication pursuant to FSS 856.011 and Resisting Arrest W/O Violence pursuant to FSS 843.02. Nicholas was later transported to BBPD for processing and later TOT PBCJ. This incident was captured on my BBPD body worn camera.
