



<p>On 6/10/17 at approximately 0500 hours I was flagged down in the parking lot of 1751 N Military Trl (Nippers) in reference to a disturbance.</p> <p>Upon exiting my car, Nippers staff advised me that they had a male strike one of their security officers in the face. Nipper's security had a W/M, later identified as Nicholas Devito, detained and laying on the ground. I placed Devito into handcuffs due to him tensing up on the security guards.</p> <p>Nipper's Security Officer Richard Nobles advised that he was closing the bar down due to it being 5am. He observed Devito harassing the DJ and causing a disturbance inside. He advised that he told Devito that he needed to leave. Devito did not comply with Nobles's request, Nobles advised him that he needed to "get out now" and Devito told him "No I fucking won't move" and to make him move. Nobles attempted to remove the beer from Devito's hand, at which point Devito attempted to punch and push Nobles. Nobles escorted Devito out with an under the arm escort. Devito kicked Nobles as he was escorting him out of the door. When Nobles was able to escort Devito out of the door, Devito then proceeded to punch Nobles in the face. Nobles attempted to take Devito to the ground, at which point he struck Nobles in the face again. Nobles could not identify which hand struck him in the face. Devito was detained by other security officers until my arrival.</p> <p>I spoke with Head Security Officer Michael Reid who advised that he saw Nobles escorting Devito out of the bar. Devito was carrying a beer in his hand and Reid took the beer out of Devito's hand. After being escorted out, Devito turned and punched Nobles in the face. After striking Nobles, Nobles took Devito to the ground. Other security officers held down Devito until my arrival. Reid completed a sworn written statement.</p>

<p>It should be noted that Nobles was visibly bleeding from his lip and when he attempted to stand up, he stumbled and fell to the ground. Nobles suffered a laceration to his lip. Boca Raton Fire Rescue responded to treat Nobles. Nobles completed a sworn written witness statement of the incident. It should be noted that Nobles was wearing a black shirt with the word "Security" written in white lettering on the front and back of the shirt. Nobles provided a Florida Licensed Security Officer card (#D2800060) that documents that he is a licensed security guard in the State of Florida.</p> <p>Devito was searched and placed in the rear of my marked BRPD vehicle (168). It should be noted that Devito had the odor of an alcoholic beverage emanating from his breath; he had trouble standing up and walking. While in the back of my vehicle, Devito spontaneously uttered that he felt a guy grab his arm so he swung and punched the person grabbing his arm. Devito was transported back to the Boca Raton Police Department holding facility for processing.</p> <p>Based upon my investigation, Nicholas Devito was placed under arrest for Battery on a licensed security officer, a criminal violation of FSS 784.07 (2B). Richard Nobel was engaged in his duties as a licensed security guard and wearing a uniform that bears proper insignia when he was struck by Devito. Devito was transported to the Palm Beach County Jail for final disposition.</p>
