I was stopped at a red light on Lantana Rd at the intersection of Edgecliff, facing west in my marked patrol car. I observed a vehicle approaching the intersection eastbound at a high rate of speed. The vehicle, a gray SUV, crossed the stop bar and the crosswalk with all 4 tires. When the light turned green, the SUV (later identified as tag 269RIK) accelerated east. I made a u turn and attempted to catch up to the SUV which was traveling at a high rate of speed. I caught up to the SUV at the intersection of Haverhill Rd stopped in the left turn lane. When the light turned green, the SUV accelerated and crossed the right lane line of northbound Haverhill Rd. I then activated my in car camera as the SUV hit the left lane line on multiple occasions and completely crossed the right lane line on multiple occasions. It accelerated to 60mph in a 45mph zone. The SUV stopped at a red light at Nautica Lakes Blvd and then quickly accelerated again. It again fully crossed the right lane line on multiple occasions. As it approached the intersection Melaleuca Ln it had to slam on the brakes to not hit a Pickup truck in front of it. As it continued past the intersection it accelerated to approximately 60mph again and I activated my emergency lights. The SUV passed several places to pull off of the road and eventually came to a stop diagonally in a drive way, blocking the sidewalk.

I approached the vehicle and found W/F Nichole Wright 9/17/89 in the drivers seat with a freshly lit cigarette. I asked her if everything was ok because of her driving and she said she was arguing with the W/M passenger. I noticed that her eyes were glassy and there was an odor of an alcoholic beverage coming from inside the SUV. I asked her if she had been drinking and she said she had "2 drinks".

I then called for a DUI investigator and turned the investigation over to INV Zeitz.

# D.U.I. PROBABLE CAUSE AFFIDAVIT

## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On the above date and time, I responded to the scene of a traffic stop conducted by Sgt. Aultman #24978. The stop was conducted on Haverhill Rd just South of Lake Worth Rd. Sgt. Aultman advised that he stopped at the red light at Lantana Rd and Edgecliff facing Westbound. He observed a vehicle approach the intersection at a high rate of speed. The vehicle stopped in the intersection with all 4 tires past the stop bar and crosswalk. He identified the vehicle as a gray suv bearing FL tag 269RIK. The vehicle left its lane of travel multiple times and was traveling 60mph in a 45 mph zone. Sgt. Aultman stated the gray Mitsubishi almost struck a truck in front of it and had to slam on its brake to avoid a collision.

Sgt. Aultman approached the vehicle and identified the driver as W/F Nichole Wright by her Florida Driver License. Sgt. Aultman observed articulable indicators of impairment and called for a DUI unit to conduct an investigation. Sgt. Aultman provided a supplemental probable cause affidavit detailing his observations.

### OBSERVATION OF DRIVER:

Upon making contact with the driver who was identified by her Florida driver license as W/F Nichole Wright, I immediately detected an obvious and strong odor of an unknown alcoholic beverage emitting from her person and breath. This odor intensified as I spoke to her. She had glassy, glazed, and blood shot eyes. Wright's speech was slurred and thick. Her movements were slow and deliberate, and lethargic with poor coordination. Wright had extreme difficulty maintaining her balance while exiting the vehicle and fell back into the car when exiting. Wright had an unsteady gait while walking to my patrol vehicle and had difficulty following directions given to her. She was wearing a black sweatshirt, blue shorts, and brown flip-flops.

### DRIVER'S STATEMENTS:

Pre-Miranda: Stated that she was coming from Alabama Joes (bar) and had 2 martinis.

Post-Miranda: Confirmed that she was coming from Alabama Joes, but this time stated that she had 3 beers and 2 vodka and cranberries. Also stated that she smoke some marijuana earlier that morning before driving home from Disney World.

### ODORS:

A strong and obvious odor of an unknown alcoholic beverage was emitting from her person and breath which intensified as I spoke to him.

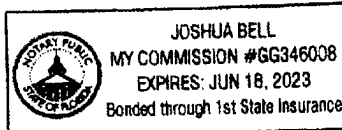

**Other Observations:**

Wright would sway roughly in a side to side front to back pattern throughout the task. VGN was observed in both of Wright's eyes.

**WALK & TURN:**

I explained and demonstrated the instructions for the "Walk & Turn" to Wright who stated that she understood. During the task, I observed her to sway roughly in a side to side, front to back pattern throughout the demonstration phase. She could not maintain her balance while listening to instructions. She stepped out of the instructional stance during the demonstration to catch her balance. Wright started the task before being instructed to do so. She missed heel-to-toe steps and stepped off the line. Wright performed an improper turn. Additionally, Wright performed the incorrect number of steps.

**ONE LEG STAND:**

I explained and demonstrated the instructions for the "One Leg Stand" to Wright who stated that she understood. During the task, I observed her to sway roughly in a side to side, front to back pattern throughout the demonstration phase. She continued to sway while balancing on one leg. She used her arms for balance by raising them more than 6 inches from her sides. Wright failed to count out loud or properly by thousands as instructed. She put her foot down to regain balance numerous times before the 30 seconds had elapsed.

**FINGER TO NOSE:**

I explained and demonstrated the instructions for the "Finger to Nose" task to Wright who stated that she understood. During the task, I observed that she swayed roughly in a side to side, front to back pattern throughout the demonstration phase. She did not keep her eyes closed. She failed to return her arms down to her sides as instructed after touching her nose. Wright's index finger did not touch the tip of the nose on 4 of 6 attempts. She searched for the tip of her nose using the finger to find her nose prior to touching the tip. The sequence used for this task was L, R, L, R, R, L.

**ROMBERG ALPHABET:**

I explained and demonstrated the instructions for the "Rhombert Alphabet" task to Wright who stated that she understood. During the task, I observed her to sway roughly in a side to side, front to back pattern throughout the demonstration phase. She would sway more than 2 inches. Wright properly recited the alphabet.

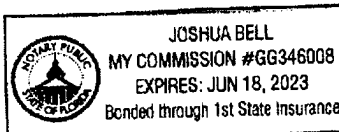
