On 09/01/2017 at approximately 2141hrs, While on patrol I observed a Silver Infinity 4 door bearing Florida Tag HLJ-G12, in the 2400 Block of Wellington Green Dr, in the parking lot of the "Park and Ride". This parking lot is known for narcotic activity. I approached the vehicle and could smell a small strong odor of smoked and un smoked marijuana coming from the passenger compartment. I approached on the passenger side of the vehicle. The passenger later identified as Nicholle Mancera, was extremely nervous. Her heart rate was elevated and her breathing was shallow and rapid. I asked Mancera for her identification. Her purse was at her feet on the floor board. Mancera pulled out a pill container and attempted to kick it under the passenger seat. In the pill container was a green leafy substance that field tested positive as marijuana. Mancera was asked to step out of the vehicle. Mancera complied and was placed in handcuffs that were double locked and checked for tightness. The vehicle was driven by a back male later identified as Tyquell Hayes. Hayes was also placed into handcuffs that were double locked and checked for proper fit. I searched the vehicle and did not locate any other contraband.

Mancera was in violation of F.S.S. 893.13 (6b) (possession of marijuana under 20g). Mancera was turned over to the Palm Beach County Jail for processing.
