
On March 11, 2018, at approximately 2315 hours, while on routine patrol in my marked PBSO patrol vehicle, I observed a Bronze in color Kia SUV bearing Florida license plate number 473NUM traveling northbound on US Highway 1. I observed the vehicle to have no headlights or taillights working and was completely dark while traveling down the road. While running the vehicle tag through PBSO Communications I observed the vehicle drift to the right almost striking the curb. I then activated my overhead lights and sirens conducting a traffic stop while came to a final stop at US Highway 1 and Northlake Boulevard, just east of the intersection.

As I approached the vehicle I observed the driver, later identified by FL DL as W/F Nicola J Mastin 10/23/70, shuffling through papers for an extended amount of time. I then attempted to signal the driver using my brightly lit flashlight to get her attention to roll the window down. As soon as the driver rolled the window down I could smell a very strong and obvious odor of an unknown alcoholic beverage, which became stronger as I spoke with Mastin. I then informed Mastin for the reason for the stop, which was her driving down the road with no lights on. She advised she had no idea that her lights were not on. She later told me that the vehicle is hers and that she has driven and owned the vehicle for approximately three years. After requesting her Driver's License, vehicle registration and proof of insurance she began to shuffle through credit/debit cards searching for her license and took her longer than normal to locate her Driver's license. After handing me her driver's license she sat back and looked at me as if she forgot that I requested her vehicle registration and proof of insurance.

Based on the strong smell of an unknown alcoholic beverage coming from the inside of the vehicle and seemed to be coming from the breath of Mastin I requested a DUI Investigator's assistance. Investigator Levey arrived on scene and took over the investigation while I conducted scene safety.

This includes my involvement in this case.
