On May 11, 2019 I was on routine patrol in my marked patrol car in Palm Beach County. I responded to the scene of a possible intoxicated driver that was located on F95 (State Road 9) northbound at Gateway Blvd. I arrived on scene and was told by the FDOT Road ranger that he previously stopped with this vehicle near Atlantic Ave and F95 in Delray Beach He stated that when he approached the vehicle he observed the driver asleep behind the wheel with the engine running. He then called for FHP assistance and I arrived on scene. I approached the vehicle and observed the driver asleep behind the wheel. I knocked on the window and awoke the driver. He eventually rolled down the window and I identified myself to the driver. He provided a FL DL and was identified as Nicolas Sangricco. I observed that he had bloodshot glassy eyes surred speech and the odor of an unknown alcoholic beverage emitting from her breath as he talked. I requested that he step out of the vehicle and walk to my patrol car. As he walked I observed that he swayed while he walked. As he stood in front of me I observed that he had an orbital sway, slurred speech, and the odor of an unknown alcoholic beverage was emitting from his breath as he talked. I also observed that he had bloodshot glassy eyes. I requested that he talked is particle.

exercises and he agreed. He stated that he had an herniated disc in his back and that his eyes shake sometimes. Horizontal Gaze Nystagmus

Before beginning the exercises, I checked to see if Mr. Sangricco was wearing glasses or contact lenses. It was determined that Sangricco was wearing glasses and removed them. I then checked Sangricco's eyes and observed equal tracking and equal pupil size. Sangricco was instructed to place his feet together and place his hands down at his side. He then was instructed to keep his head still and follow the stimulus with his eyes and his eyes only. He was also instructed to keep looking at the stimulus until told not to. Sangricco verbally indicated that he understood.

- Lack of smooth pursuit, left eye
- Lack of smooth pursuit, right eye
- A distinct and sustained nystagmus at maximum deviation in the left eye
- A distinct and sustained nystagmus at maximum deviation in the right eye
- An onset of nystagmus prior to 45 degrees in the left eye
- An onset of nystagmus prior to 45 degrees in the right eye

I estimated the initial angle of onset to be 35°. I did not observe resting nystagmus or vertical nystagmus. I observed Sangricco to have an orbital sway. The eyes did not converge and his eyes stayed straight.

#### Walk and Turn:

The area was level and free of debris. He indicated that he observed the line on the ground. He was instructed to put his left foot on the line, then place his right foot on the line ahead of the left foot in a heel to toe manner. I then demonstrated this position. He was instructed not to begin untold to do so. He verbally indicated that he has understood all instructions up to this point. He was then instructed to take 9 heel to toe steps on the line when told to do so. I then demonstrated this. He was then instructed to turn on the ninth step and to keep the front foot on the line and to take a series of small steps with the foot on the line. I then demonstrated this. He was also instructed to keep his arms at his sides and to watch his feet during the exercise. He was also instructed to count aloud and to not stop once he begins the exercise. He was also instructed to keep his arms at his sides at all times.

While he completed the exercise I observed that he stepped off the line on multiple steps and missed heel to toe on several steps. I also observed that he stopped after completing the turn and asked for further instructions. He also had a sway as he walked on the line.

#### One Leg Stand:

He was instructed to stand with his feet together and to place his arms down at his side. He was instructed to maintain that position until told to do so. Once told to do so, he was instructed to raise his right leg approximately 6 inches off the ground and to keep both legs straight with both arms at his side. He was also instructed to look at the elevated foot and count aloud in the manner of one thousand-one, one thousand-two and so on until told to stop. He verbally indicated that he understood the instructions after I demonstrated to him.

During the exercise he raised his right foot. I observed that he had an orbital sway during the exercise. He also placed his foot down. He also did not look down at his foot while completing the exercise.

#### Finger To Nose

He was instructed stand with his feet together and arms at his side and to have his index fingers pointed out. He was instructed to start and stay in that position until told to do so. He stated that he understood. I then demonstrated the position. He was then instructed to when told to start to close both eyes and tilt his head back. When told to do so he was instructed to bring the hand I directed upward, touching the tip of your finger to the tip of his nose. I then demonstrated this. He was then instructed to after touching the tip of the nose to immediately bring his hand down to his side. He stated that he understood. I then demonstrated and he stated that he understood. He was instructed to raise his hand in the following order, left, right, left, right, and right, left.

- -Left: Miss. Didn't put arm down.
- Right: Miss. Didn't put arm down.
- -Left: Miss -Right: Miss
