PROBABLE CAUSE

On 1/15/16 at approximately 9:48 PM, I (Officer Jarrell) and Corporal Yildiz responded to a disturbance at 118 Chapel Ln, Tequesta.

Upon arrival, I met with Nicole Blythe (W/F DOB 9/21/1980) who advised that she called Police because she and her father, Thomas Blythe, got into an altercation. She wanted to call the Police because she believed her father was calling the Police as well. While speaking to N. Blythe I could detect a smell of an unknown alcoholic beverage emanating from her person. N. Blythe stated that she got mad at her daughter who locked herself in the room and wanted to talk to her. While trying to get her out, T. Blythe told her to stop and started recording the incident. During this time, she stated T. Blythe grabbed her by the neck so she hit him in defense. She insisted she was not the first person to be attacked.

I then spoke with T. Blythe who stated N Blythe came home intoxicated and started an argument with him and his wife Donna Blythe. The argument got "ugly" and her daughter, Amber Knode, locked herself in the room trying to get away from the argument. T Blythe started recording the incident on his phone, at which point N Blythe knocked the phone out of his hand and then struck him in the left side of the face, leaving red marks. She then attempted to get Knodde out of her room, but she would not come out because of fear. N Blythe then kicked the door down and broke it off the hinges. She then hit Knodde multiple times on the left side of her face, causing red marks. T Blythe then stated that when Knodde, ran out of the room, N Blythe hit Knodde several more times in the face.

I also spoke with Amber Knodde, who gave a matching statement to T Blythe.

Based on the totality of circumstances, I believe probable cause exists to charge Nicole Blythe with domestic battery pursuant FSS 784.03(1)(a)(1) with two counts.


