

	<p>Upon arrival while approaching the residence I observed a female come from the residence and was screaming. I observed her with blood on her body. As Officer Reynolds (#320), Officer Arnold (#441), and I approached the residence we observed a male seated inside the house at the table calm.</p> <p>While the other Officers attempted to secure the male half, I attempted to speak to the female half. She was later identified as, Nicole Broch. Broch refused to answer any of my questions. At one point while attempting to speak to her she said he tried to kill her. She then told me to contact her attorney. I continued to try to determine what happened and see if there were any unknown threats inside the house. Broch refused to answer continuing to tell me to contact her attorney. I did observe her foot to be cut and her back had a cut. I also observed her pants to be wet as if she had urinated herself. She smelled strongly of alcohol.</p> <p>I went inside the residence and spoke to the male half, identified as Trenton Bongard. Bongard said that Broch is his girlfriend/ex-girlfriend. He stated that they have a "on again off again" relationship. He stated that they have been in an intimate dating relationship for a total of 3 years. Bongard said that tonight he got into a verbal dispute with Broch over something his parents said to her 2 years ago. He stated they both had been drinking alcohol tonight. He said she got mad and began to break numerous items inside the residence. Broch also broke an ash tray outside on the patio. Bongard said that she cut her foot open on the ground where the ash tray was. He also said she fell on her back onto the debris from the broken items. He said that is how she received cuts on her back and foot. Bongard stated that Broch threw numerous items at him. One item he said she threw at him was a lamp that was broken on the stairs. Bongard said that during the fight Broch began to hit him in his face. He pointed at the left side of his face. He said she hit him approximately 20 times, with an open hand and a closed hand. I observed the area he stated she hit him to be red. I also observed his entire face to be red which could be possibly due to drinking. This statement was sworn and captured on my BWC.</p> <p>I examined the physical evidence at the scene, and determined it appeared to be from someone breaking items. I also observed the broken lamp in the same location that Bongard said Broch threw it at him. On the patio I observed the broken ash tray with clotted blood on the ground. It appeared as if someone had been injured on the ash tray. I also noted blood throughout the residence.</p> <p>While looking at Bongard I noticed no blood on his hands indicating he was in a physical altercation. I did notice blood on his foot and legs from being in the area with Broch while she was bleeding. I did not see any blood under Bongard's finger nails. There were no bloody knives inside the residence, nor any that seemed to be freshly washed.</p> <p>Based on the physical evidence and statements I find probable cause to place Broch under arrest for violation of Florida State Statute 784.03(1)(A)(1) Simple Battery (Dating Violence). I find this probable cause due to Broch physically hitting Bongard in the face. I find her to be the primary aggressor based on the evidence inside the house, the injuries to her, and the statements.</p> <p>Broch was transported to Palm Beach Gardens Medical Center by Fire Rescue, and Officer Johnson (#451) followed them. After Broch was medically cleared she was transported to the Palm Beach County Jail.</p> <p>Nothing further to report from this Officer.</p>
