On 10/19/2017 at approximately 2239 hours, I responded to 21445 Town Lakes Dr in reference to a domestic disturbance. Upon my arrival, I met with W/F Nicole Andrade who stated that she was in an argument with her boyfriend whom she lives with and has a child with.

Andrade stated that following an argument about leasing arrangements, her boyfriend W/M ██████████, wanted to leave their apartment. While ██████████ was attempting to leave their apartment, Andrade stated that she was trying to stop ██████████ from leaving by grabbing on to him. She stated this was the extent of the physical contact.

After speaking with ██████████ he verified the events, stating that during an argument he was trying to leave the apartment when Andrade grabbed onto him trying to prevent him from leaving. ██████████ attempted to push past Andrade to be able to leave the apartment. He stated they then separated and he left the apartment.

I observed minor scratch marks to ██████████ torso on his right side rib cage and left side chest. I also observed a minor scratch mark on Andrade's right arm.

After my investigation I placed Nicole Andrade under arrest for domestic battery under FSS 784.03(1). She was then transported to BRPD booking for processing and then TOT CJ.
