Officer Fandrey verbally advised me he was Furrough operating her 2013 Kia bearing Florida license plate Y35AIV in an unusual manner. The driving behavior he observed included swerving within her lane and multiple wide turns. Officer Fandrey advised me he stopped Furrough based on his suspicion that she was sick, tired, or impaired. Officer Fandrey further advised me that Furrough stated she didn't think she should be driving and was a "4" on an impairment scale of 1-10. Officer Fandrey further advised me that Furrough had bloodshot, glassy eyes and odor of an unknown alcoholic beverage on her breath.

Upon my arrival, Furrough was out of her vehicle and leaning against a police vehicle with Officer Matonti nearby.

OBSERVATION OF DRIVER:

I observed that Furrough had bloodshot, glassy eyes and I could smell the odor of an unknown alcoholic beverage on her breath.

On "1000-6" Furrough placed her foot down and started to hop to her left. Furrough was swaying during the task. Furrough counted "1000-18" twice.

FINGER TO NOSE:

L1: Furrough used the pad of her finger to touch the tip of her nose. Furrough forgot to put her finger back down to the side again and I reminded her to do so. R2: Furrough touched her face under her right eye, missing her nose completely. L3: Furrough touched her nose to the left of the tip with the pad of her finger. R4: Furrough touched along the right side of the bridge of her nose and used the pad of her finger. R5: Furrough used the pad of her finger to touch her nose above the tip. L6: Furrough used the pad of her finger to touch the tip of her nose.

ROMBERG ALPHABET:

Furrough stated the alphabet correctly but said it rhythmically rather than in a monotone manner.


