I met with Jake Lynch, who appeared to have a large laceration above his left eye, which was bleeding. Lynch explained that his long term boyfriend, Nikolas Ramadan approached him to look for his cell phone inside of Lynch's vehicle, and possibly get a ride home. Lynch then explained that Ramadan was intoxicated, and he was attempting to get Ramadan inside the vehicle, and wait for a ride home from the AAA towing company. According to Lynch, Ramadan became combative and punched him in the face. Lynch said he immediately grabbed the hands of Ramadan, and then they wrestled on the ground.

I met with Ramadan who was sitting on the curb. Ramadan explained that he came toward Lynch in an attempt to look for his phone. According to Ramadan, Lynch attempted to speak with him, and asked him to wait by the vehicle. According to Ramadan, Lynch was attempting to "calm him down", but in the moment, Ramadan got angry and punched Lynch in the face.

Both subjects explained that they have been in a relationship with each other for well over a year. Ramadan stated that they were living together, but he moved out approximately five months ago.


Based on the following, Nikolas Ramadan was found to be the primary aggressor and was arrested for domestic simple battery according to F.S.S. 784.03(1A1).
