Stop conducted by Corporal J. Franklin for speed. 75 MPH in a posted 45 MPH zone.

### OBSERVATION OF DRIVER:

See CPL J. Franklin's supplement for his observations. My observations are as follows. Schultheis used the driver door of his vehicle for support upon exit. Schultheis presented with an orbital sway throughout our entire interaction. Schultheis was reluctant to perform SFST's due to his past arrest. Schultheis wanted the SFST's video recorded due to his distrust of law enforcement. Schultheis was read Taylor Warnings and gave consent to SFST's.

### DRIVER'S STATEMENTS:

Schultheis stated that he had not consumed any amount of alcohol. Schultheis repeatedly expressed his concern for his past arrest and offender status that he would be treated unfairly and did not wish to complete SFST's until his Taylor Warnings were read.

### ODORS:

Odor of an unknown alcoholic beverage emanating from the driver side window of the vehicle.

SPEECH: Slightly slurred, slow and thought out, deliberate, repetitive.

Schultheis failed to follow the stylus with either eye four separate times.

**WALK & TURN:**

Schultheis was instructed to place his feet together and his hands by his side. Schultheis had an orbital sway while the directions of the tasks were explained. Schultheis repeatedly raised his arms more than six inches to maintain balance. Schultheis was again instructed to keep his hands by his sides during the task. Schultheis began the task two times before the completion of the instructions. When instructed to begin, Schultheis lost balance and stepped off the line two steps to his left to regain his balance. Schultheis regained his balance and continued the task. Schultheis stepped off line on step three, five, six. Schultheis failed to walk heel-to-toe on steps six and seven. Schultheis struggled to maintain balance during the turn, stepping off line. Upon return, Schultheis stepped off line step five and failed to walk heel-to-toe on steps three and four.

**ONE LEG STAND:**

Schultheis was instructed to place his feet together and his hands by his side. Schultheis had an orbital sway while the directions of the task were explained. Schultheis stepped off position in an attempt to maintain balance. Schultheis raised his arms more than six inches to maintain balance. When instructed to begin, Schultheis raised his foot and placed it down on count one. Schultheis again raised his foot less than six inches, counting to 1006 and placed his foot down again. Schultheis again raised his foot stated 1007, placed his foot down and discontinued the task.

**FINGER TO NOSE:**

Schultheis was instructed to place his feet together and his hands by his side. Schultheis had an orbital sway while the directions of the tasks were explained. When instructed to begin Schultheis placed his right index finger tip to the tip of his nose. Left index finger pad to bridge of nose. Right index finger tip to tip of nose. Left index finger pad to nose, then searched for the tip of the nose. Left index finger pad to the nose, then searched for the tip of the nose. Right index finger pad to the tip of the nose. Left index finger pad to the tip of the nose. On each hand movement to the nose Schultheis lowered his head to meet the fingers. Schultheis opened his eyes on the last two commands.

**ROMBERG ALPHABET:**

Schultheis was instructed to place his feet together and his hands by his side. Schultheis had an orbital sway while the directions of the tasks were explained. Schultheis raised his arms from his sides more than six inches to maintain balance. Schultheis recited the alphabet in a slow, calculated and deliberate manner thinking about each letter prior to saying it. Schultheis recited A, B, C, D, E, F, G, H, I, J, K, L, M, N, O, P, Q, R, S, T, U, V, W, X, Y and Z.
