While I was behind it I could still hear the engine. The SUV veered to the right and back into the appropriate lane of travel as a vehicle approached in the southbound lane. I then activated my overhead lights and conducted a traffic stop. The SUV slowed sharply and then pulled off the road. I made my approach from the passenger side of the vehicle. I noticed that there was one occupant and that the vehicle was not in park. I introduced myself and asked the driver for his license, registration, and proof of insurance. He slowly looked up at me and with slurred speech told me that he does not speak very much english. At that time D/S Sentmanat, ID #24968 arrived and approached along the driver side. D/S Sentmanat took over the stop and initiated a DUI investigation.</p> <p>This concluded my involvement in the case.</p>

I responded to S. 57th Ave and Pine Ridge Cir, Greenacres, FL 33463 at approximately 0302hrs in reference as a back-up for Deputy Miller #24991 on a traffic stop. When I arrived and spoke with the driver I began a D.U.I. investigation. See D/S M. Miller's supplemental probable cause affidavit for the driving pattern (see attached).

OBSERVATION OF DRIVER:

Upon arrival I observed the driver W/M Norberto Flores Ruiz (09/01/81) had bloodshot/watery eyes. Flores was having some difficulties locating his registration and I observed him chewing gum. I asked him to spit out his gum and he began chewing faster. Again I asked his to spit out the gum, he chewed it a few times, and spit it out. Flores exiting the vehicle and he appeared to be swaying.

DRIVER'S STATEMENTS:

Flores advised that he was at a friend's house and that he only had drank two beers.

ODORS:

Flores had a strong odor of an unknown alcoholic beverage coming from his breath and person. While sitting in the back of my marked patrol unit there was a very strong odor of the unknown alcoholic beverage within my vehicle interior.

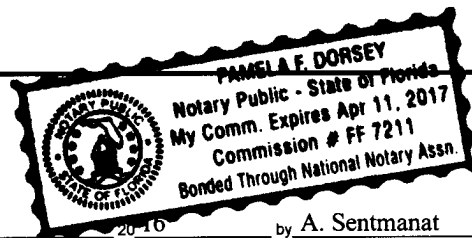

As Flores stood with his feet together he was swaying side to side.

WALK & TURN:

Flores stumbled out of the starting position six times. He crossed his feet on steps 3, 4 and on the walk back at step 8. Flores made an improper turn and at times did not walk heel to toe. On the walk back he stumbled left on step 2 and stumbled right on step 5.

ONE LEG STAND:

Flores raised his right foot and at times try to bend the knee. He used his left arm for balance by holding it out. He dropped his foot on the fifth count and at times would lean to the left.

FINGER TO NOSE:

While Flores was in the starting position he would be swaying in a star like pattern. After giving the instructions, demonstrating it, and told him "left" he just raised his arm up. On all the attempts with his left and right hand Flores missed the tip of his nose. He would either touch the bottom or the side of the nose.

ROMBERG ALPHABET:

I asked Flores to count from 1 to 24. Flores counted to 30. Through out this task Flores was swaying side to side.

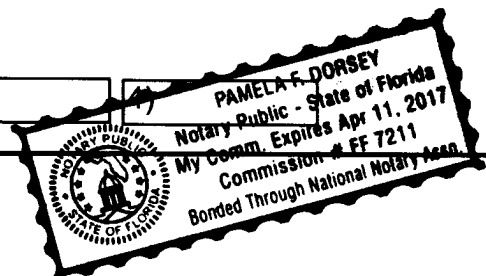
