Sanchez #24967 responded to [REDACTED] in reference to a dating violence related battery. Upon arrival contact was made with the victim W/M [REDACTED] (DOB- 04/06/1984) who advised me of the following:</p> <p>[REDACTED] stated that he and the defendant W/F Noris P. Alvarado Negrón (DOB 09/22/1987) were in a dating relationship for nearly one month. [REDACTED] stated that they were sexually involved and occasionally went on dates together. [REDACTED] stated that he had broken up with Negrón about one week ago and she has been sending him text messages ever since. [REDACTED] stated he blocked her number and she continued to insult him over messages in "WhatsApp". [REDACTED] advised that Negrón has never been to his residence and somehow found his address and taunted him over text message to come outside. [REDACTED] stated he came outside to ask Negrón to leave his property and she began screaming at him. [REDACTED] advised Negrón that he was calling 911 and that's when Negrón slapped [REDACTED] on the left side of his cheek with an open right palm. [REDACTED] stated that she then walked away and as [REDACTED] turned around to go inside Negrón came up and kicked him in his buttocks. [REDACTED] stated that Negrón then left the area on foot southbound on Jennings Ave and he awaited deputies.</p> <p>Contact was then made with Negrón. Negrón stated that she indeed came over to [REDACTED] residence to confront him as to why he broke up with her. She stated that she deserved to know why he broke up with her. When asked if she had ever touched him physically, Negrón advised she never touched him. [REDACTED] had a red distinctive welt on the left side of his cheek where it appeared to have swelling from four fingers. No marks were observed on his clothing near his buttocks.</p> <p>Based on the aforementioned investigation and evidence, I find probable cause to arrest W/F Noris P. Alvarado Negrón (DOB 09/22/1987) for Simple Battery (Dating Violence), pursuant to F.S. 784.03(1A1). Negrón was then placed in handcuffs that were checked for tightness and double locked. She was transported to PBSO D16 for processing and later to the PBC Jail.</p>
