On 01/06/18 at approximately 0250 hrs, I responded to 10608 Cypress Lakes Preserve Drive in Lake Worth, Palm Beach County in regards to the report of a Domestic Dispute.

Upon my arrival I spoke with the complainant who identified herself as Negris Koyuncu. Negris stated that her husband Okkes Koyuncu hit her and wrestled her to the ground after a night drinking with friends. She stated that Okkes was upset that she was playing too loud and attacked her. Okkes grabbed Negris by the arm and threw her on the floor and punched her several times with a closed fist.

Okkes admitted to drinking and getting into an argument with Negris but nothing more. He later admitted to wrestling her to the floor but denied punching her.

I observed the strong order of alcohol coming from Okkes, who was said to have consumed a half a bottle of wine by Negris.

I observed red marks on Negris's arms and minor redness above her left eye. Negris refused medical attention. Negris also refused to allow having pictures taken and she refused to write a statement. Based on my investigation I have probable cause to arrest Okkes Koyuncu for Battery (Domestic Violence) which is a violation of F.S.S. 784.03(1)(a)(1).

Once the necessary paperwork was completed, I transported Okkes to the County Jail.
