been drinking earlier in the evening. She and Olgierd became involved in a verbal argument over several topics, to include his drinking problems, repairs around their household as well as Christmas gifts. According to Stacey, while she was arguing with Olgierd, she had a cup of water in her hand. During the altercation, Olgierd smacked Stacey's hand, causing it to spill on him. Stacey then stated that Olgierd proceeded to eat a Clementine orange, chewed it in his mouth, then spit pieces of the orange at her, striking her face. Stacey had no visible markings or bruising on her body, however there were several small pieces of orange debris stuck to her neck and in her hair, indicative of being spit on. Photographs of the orange pieces were taken and submitted to BRPD Evidence. Stacey confirmed that no witnesses were present during the altercation.

I then spoke with Olgierd, who appeared to be intoxicated due to the smell of an alcoholic beverage emanating from his person, his slurred speech, and instability on his feet. According to Olgierd, he and Stacey were arguing over a Rolex Christmas gift and that nothing physical had occurred between he and Stacey. It should be noted that Olgierd's right sleeve was soaking wet, with the rest of his shirt dry. When asked about his wet sleeve, Olgierd stated that he sweats a lot, despite only one sleeve being wet. Furthermore, when Olgierd was asked about the pieces of orange food debris on Stacey's neck, he only repeated, "she has food on her neck," and provided no further explanation as to how it had gotten on her neck and hair.

Due to Stacey's account of the incident corroborating the physical evidence available, in addition to Olgierd's inability to provide any explanation as to how his shirt became wet and how the chewed up orange debris became stuck on Stacey's neck and hair, I developed probable cause that Olgierd Wielecki did actually and intentionally strike his wife's hand, causing a cup of water to spill onto him, and additionally spit chewed a chew up Clementine orange on his wife against her will, in direct violation of F.S.S. 784.03(1A1), Domestic Simple Battery.

Olgierd was then arrested and placed in handcuffs, which were checked for tightness and double locked. He was then transported to the Boca Raton Police Department Booking Facility where he was processed. Olgierd was then transported to the Palm Beach County Jail, where he will await final disposition.

Stacey was offered a Domestic Violence Victim's Rights Pamphlet, which she refused. A victim notification form was completed and provided to the Palm Beach County Jail.
