PROBABLE CAUSE STATEMENT	<p>In the City of Riviera Beach, Palm Beach County and State of Florida, the following occurred:</p> <p>On Saturday, October 8th, 2016, at approximately 2209 hours, while patrolling in the 2500 block of Broadway (in a marked police vehicle), I observed two females (later identified as Sirlena Y. Harris, B/F, DOB 09/22/66, and Pamela J. Garruto, W/F, DOB 05/07/70), and two males (later identified as William Freeman, B/M, DOB 11/16/68, and Roosevelt Tolbert, B/M, DOB 09/06/69), standing at the rear of Marathon Gas Station, located at 2520 Broadway (during business hours).</p> <p>I made contact with the subjects (in full police uniform), and advised them that they were Loitering. The subjects were unable to dispel my suspicions and were detained on location. I observed a posted "No Loitering" black and white in color sign on the back wall located on the northeast corner of the above location.</p> <p>I observed Sirlena Harris, consuming what appeared to be an alcoholic beverage (later identified as a Colt 45 16 oz. of beer). I recovered their beer can and advised the subject that she was in violation of City Ordinance 3-10 (Drinking Intoxication Beverages).</p> <p>All subjects were arrested and charged with Loitering. Sirlena Harris was also charged with Drinking Intoxication Beverages.</p> <p>All subjects were issued a Notice To Appear (which included a court date), and released on scene.</p>
