95 (State Road 9) south of Woolbright Rd. I observed Trooper Tavares behind a black in color Mercedes Benz in the outside center lane that was closed off due to the active work zone. I also observed a white female standing outside the passenger side of Trooper Tavares's patrol car on her phone who was later identified to be the driver of the black in color Mercedes Benz. The white female driver was identified through her Florida driver license to be Pamela Lorene Giustizia 05/11/1969. Trooper Tavares advised me on the reasoning of the traffic stop and what he had observed along with his concerns of the driver possibly being impaired. I then approached Ms. Giustizia advising her of who I was and the reasoning I was there, which was to assist Trooper Tavares in regards to him having reason to believe she was driving under the influence of alcohol and/or a controlled substance. Ms. Giustizia appeared to be off balance as she was swaying while standing and exhibited red in color, glossy eyes. Ms. Giustizia was asked if she had been drinking resulting in her advising me that she had been drinking, but hours ago and that she had just eaten a big thing of gelato. As Ms. Giustizia spoke, outside of her vehicle and face to face with me on the roadway, I could smell the odor commonly associated with the smell of an unknown alcoholic beverage emitting from her breath. Ms. Giustizia was questioned on if she had any medical or physical disabilities to which she denied having anything other than high blood pressure. Ms. Giustizia was also asked if she was taking any medication to which she denied taking anything other than the medication for her high blood pressure. Ruling out any medical concerns or physical disabilities, Ms. Giustizia was then asked to perform a series of roadside exercises to which she consented and agreed to perform (see roadside task sheet)

The area for the following roadside exercises was free of debris. Subject agreed to use a straight line to perform the walk and turn exercise. Subject was asked if she had any problems with her eyes aside from corrective vision, or injuries that would prevent her from performing any of the exercises that would be requested of her to perform. Subject advised that she did not have any physical body injuries or limitations and would be able to perform the exercises requested of her to perform.

Inside the Palm Beach County Jail's breath alcohol testing facility (BAT) Ms. Giustrzia began a 20 minute observation prior to being provided an opportunity to provide a breath sample. After Ms. Giustrzia's 20 minute observation, she was given an opportunity to provide a breath sample to which she refused to provide. Ms. Giustrzia was then read implied consent and was requested once more to provide a sample of her breath resulting in her refusing at approximately 04:30 AM.
