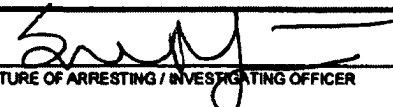

On 07/07/2019 at approximately 2330 hours, I was driving my marked unit SB in the area of 1900 N Federal Highway. I immediately observed a Black Toyota bearing FL Tag#DVRA36 driving Northbound on N Federal Highway with no lights activated. I then did a U-turn and got behind the Toyota, which was swerving in its lane. I then conducted a traffic stop on the vehicle in the area of 3600 N Federal Highway. The vehicle pulled into the left turn lane and came to a stop. I approached the vehicle on the driver's side and came into contact with W/F driver Paris Pierce. I immediately could smell the strong odor of an alcoholic beverage emitting from her person. Her eyes were red and glassy and she was stumbling over her words while speaking to me. Pierce stated that she was picking up her friend from Mizner Park because she was too intoxicated to drive and was taking her home. Officer Murphy instructed Pierce to turn the vehicle off, which she was unable to do quickly, fumbling around with the controls. Pierce also could not locate her purse and wallet to provide her driver's license, which were visible from my perspective on the driver floor board. I then requested Pierce to step out of the vehicle and she complied. The odor of an alcoholic beverage was still present. She stated that she had no medical conditions and no injuries. Ofc Crowe arrived on scene. It should be noted Pierce stated that she had just been dropped off to pick up her friend recently, but later stated she had been there, Mizner Park, for a few hours. When asked if she had been drinking, she stated "a little." I then explained my observations to Pierce and asked her if she would be willing to participate in the SFST's to dispel my alarm that she was driving under the influence and she stated she would. The first task was the horizontal gaze nystagmus. I explained the instructions and she

stated she understood. She then began to complete the exercise. While observing her eyes I noticed a lack of smooth pursuit that was present in both eyes, each eye had a constant jerking while at maximum deviation and onset prior to 45 degrees was present in both eyes. The second task was the walk and turn. I explained the instructions, demonstrated it, and she stated she understood. It should be noted that she did not maintain the starting position throughout the instructions and repeatedly began before I told her to do so. She did not keep her hands by her sides throughout the exercise. She didn't touch heel to toe on multiple steps. Pierce took 12 steps down before she was instructed to stop and turn the other way. She did not take a series of small steps after her first nine steps, but instead took multiple large steps. Pierce did not watch her feet many times during the exercise. The third task was the one leg stand. I explained the instructions, demonstrated it, and she stated she understood. She then began the task. She lifted her foot approximately 2 ft and began counting out loud. Pierce was swaying back and forth during the exercise. She did not watch her feet at all throughout the exercise. Lopez did not keep her hands completely down at her sides. She was unable to count consistently and stopped holding her foot up after 23 seconds, before instructed to stop. The fourth task was the Romberg alphabet. I explained the instructions and she stated she understood. She then began saying the alphabet before told to. She then slowly sang the alphabet when told to begin. She was slightly swaying throughout the exercise. Pierce did not keep her eyes closed throughout and used her hands for balance frequently. The fifth task was the finger to nose. I explained the instructions and she stated she understood. She then began the task (L-R-L-L-R-L). Pierce used the middle of her pointer finger to touch her nose. The sixth task I instructed her to put her feet together and arms at her side. I explained to place her head back and eyes shut and count to 30 seconds in her head. When she shut her eyes, I would begin my timer and when she opened her eyes, I would end the timer. She counted to 30 seconds in about 27 seconds. She also was unable to keep her eyes fully closed and was attempted to squint hard in an effort to do so. Pierce was swaying back and forth for the duration of the exercise. Post Miranda, Pierce stated she had been drinking tonight and was driving the vehicle. Pierce was then placed under arrest for DUI under FSS 316.193(1). Pierce was transported to BRPD booking for processing. Once inside booking, Ofc Deen conducted the
