On 2/7/18, at approximately 2054 hours, I responded to 10199 Serene Meadows Dr. in unincorporated Boca Raton, Florida 33428 in reference to a domestic disturbance.

Upon arrival, I met with the complainant, Nilza Blomquist, who was sitting on the floor, crying. She was rubbing her knees, crying, as if in pain. Nilza stated the following. Her and her daughter, Patricia Andrade Pereira, began arguing over the family issues. During the argument, Patricia used her hands and pushed Nilza onto the floor, directly outside of the front door. Patricia then went back upstairs.

I then spoke to Diego Certuche, who said the following. Diego was called by Nilza to come to the house to pick up his daughter, Isabella Pereira. Once he arrived at the 10199 Serene Meadows Dr, he witnessed the Patricia use her hands to push Nilza out of the house onto the floor.

I then spoke to Patricia Pereira, who said the following; she got into a verbal argument with Nilza over family issues regarding her daughter, Isabella. She stated during the argument, Nilza became upset and began to call 911. Patricia attempted to grab a piece of paper from Nilza's hand as she thought Nilza was overreacting to the situation. Patricia stated she never touched her mother on this date. Patricia did not have injuries on her person.

Nilza's right palm and left knee appeared to be swollen and were consistent with her statements of being pushed by Patricia. Based on injuries and statements on scene, I have probable cause for the arrest of Patricia Andrade Pereira for Simple Battery (Domestic Related) per F.S.S 784.03 (1)A(1).
