# D.U.I. PROBABLE CAUSE AFFIDAVIT

## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

An anonymous caller called the Jupiter Police Department to report a black Cadillac SUV in the area of Beverly Drive. The vehicle was reportedly being driven by a short white female with blond hair and was driving on lawns in the area. The caller also stated the driver was also possibly very intoxicated. Officer Kolenich of the Jupiter Police Department responded to the area and located a vehicle matching that description. Officer Kolenich observed the vehicle as it traveled east on West Riverside Drive. The vehicle drove past a traffic control sign directing traffic to stop prior to the railroad tracks when the light was red. Officer Kolenich initiated a traffic stop of the vehicle. It was slow to respond to his direction. Officer Kolenich made contact with the driver, identified as Patricia Taylor, and developed reasonable suspicion for DUI. I was notified to respond to the scene to conduct a DUI investigation. Please see Officer Kolenich's supplemental PC for a more detailed account of his observations.

## OBSERVATION OF DRIVER:

Taylor had glassy eyes. Taylor's speech was slurred. Taylor was unsteady on her feet and stumbled as she walked away from her car towards mine. Taylor then started to insist that I walk in front of her. I could smell the odor of an unknown alcoholic beverage on Taylor's breath.

## DRIVER'S STATEMENTS:

Taylor stated she had consumed three beers prior to being stopped. Taylor at first refused to do SFSTs. I then explained them and advised her of her Taylor Warnings. Taylor then agreed to complete roadsides.

## ODORS:

Odor of unknown alcoholic beverage on subject's breath.

ATTITUDE: Cooperative, talkative, overly friendly, mood swings, sarcastic



WALK & TURN:

Taylor missed heel to toe on the first and third steps. Taylor stumbled on the fourth step, stepping off the line and missing heel to toe. Taylor again missed heel to toe and stepped off the line, blaming the wind as she stopped to gain her balance. On the sixth step, Taylor's foot got caught on her leg and she missed the line when she brought it down. Taylor missed heel to toe on the ninth step and spun around on both feet before stopping. Taylor took a step off the line and then stopped saying "I know what that means". She then stood still for several seconds. I asked her to continue. Taylor started and again stepped off the line while using her arms for balance. Taylor stopped and again tried to continue. Taylor got visibly frustrated and then walked away. I asked her what was going on and Taylor told me she was, "done". I reminded Taylor of her Taylor Warnings again and asked if she was refusing to continue. Taylor walked back to the line and took nine unsteady steps down the line, missing heel to toe and stepping off the line several times. Taylor then told me she had forgotten the rest of the instructions.

ONE LEG STAND:

Taylor used her arms for balance and put her foot down on "5". Taylor did not count as instructed. Taylor had to take a step back to stop from falling over. When she returned, Taylor exclaimed, "That's hard!" I suggested Taylor remove her shoes. Taylor did so. Taylor was again unsteady on her feet, swaying and using her arms for balance. Taylor put her foot down several more times prior to me terminating the task.

FINGER TO NOSE

L1: Taylor touched her finger over her right nostril at the first knuckle. Taylor did not put her finger back down to the side. I reminded her to. R2: Taylor touched the tip of her nose with the pad of her finger. I again had to remind Taylor to touch the tip of her nose and put her finger straight back down to the side again. L3: Taylor used the pad of her finger to touch the tip of her nose. R4: Taylor used the pad of her finger to touch the tip of her nose. R5: Taylor used her wrong finger before correcting herself and bringing the correct one to her nose. Taylor used the pad of her finger to touch the tip of her nose. L6: Taylor used the pad of her finger to touch the tip of her nose. Taylor was swaying visibly during the task.

ROMBERG ALPHABET:

Taylor stated the alphabet correctly After "T", Taylor started saying the alphabet rhythmically. Taylor was swaying visibly during this task.
