On the 4 day of January, 2018 at 03:00 (Specifically include facts constituting cause for arrest.)

On 01/04/2018 Ofc Charles and I responded to 300 NE 2nd St in reference to an accident involving a 2010 Nissan bearing Fl tag#CSSS35. Ofc Rafalko and Ofc Mcquiston were first on scene and they advised that Patricia Stefanovic was the only occupant of the vehicle. The vehicle was still running and officers had to break the windows in order to see inside the vehicle to render aid to Stefanovic. Once inside the vehicle they saw Stefanovic as the only occupant. Ofc Mcquiston advised her that he was done with his accident investigation. See Ofc Mcquiston report for further details.

While on scene I spoke with Stefanovic who advised that she was speaking to her dead sister and then she was involved in an accident. I could smell a strong odor of an alcoholic beverage emanating from her person, her eyes were blood shot and glossy and she was slurring her speech. She was then transported to Boca Regional Hospital for further treatment. We responded to Boca Regional in reference to conduct a criminal investigation. I advised her that I was conducting a criminal investigation because Ofc Mcquiston had completed the accident investigation. I then read Stefanovic her Constitutional Warnings in the presence of Ofc Charles. She became irate and tired to get out of her bed to avoid me reading the Warnings. She began yelling and screaming for help even though she was at the hospital getting treatment. Stefanovic advised that she didn't wish to answer any questions without an attorney present. Stefanovic was being treated for her involvement in the accident at 0100hrs and the nursing staff and doctors advised that they were waiting for X-ray and CT scan results before releasing Stefanovic. She received treatment and was medically cleared at 0234hrs. Based on the following observations of Stafanovic; her having an odor of an alcoholic beverage emanating from her; person her eyes being blood shot and glossy and her slurred speech. I then asked her if she would submit to the roadside sobriety tasks and Stefanovic advised that she would submit to the tasks.

I then walked her over to a well lit area and asked her if she had any medical

problems or medical issues that would prevent her from doing the tasks. The tasks that were conducted were the Walk and Turn, One Leg Stand, Finger to Nose, and the Rhomberg Alphabet. Ofc Saavedra and Ofc Coon arrived on scene.

The first SFST was the Walk and Turn. Stefanovic failed to walk heel to toe at any of the steps instead she took regular steps as she walked the line. She also made an improper turn by just turning around instead of the way that was demonstrated to her. She took 10 steps forward and then 9 steps back. She also stepped off the line and raised her hands from her sides to maintain her balance.

The second SFST was the One Leg Stand. Stefanovic failed to keep her feet six inches off the ground; she actually raised them higher than the requested six inches. She put her foot down several times during the task. She swayed during the task and at one point she hopped backwards as she lost her balance.

The third SFST was the Finger to Nose (L-R-L-R-R-L). Stefanovic had to start this task three times. The first two times on the first left she kept her finger on her nose for a period of time until I asked her if she remembered the instructions. She stated that she was waiting for me to tell her to bring her hands down. I then gave her the instructions again and asked her if she understood. Stefanovic touched her right nostril on the first, second and third left. On the first and second right she touched her right nostril. On the third right she raised left hand and then corrected herself and brought her right finger to her nose.

The fourth SFST was the Rhomberg Alphabet which she was to able to recite properly but she sang the alphabet like in a nursery rhyme. I then asked her if she understood the instructions and it was for her to recite the alphabet but not to say it like a nursery rhyme. I then asked her if she wanted to say the alphabet again and she stated yes. Stefanovic recited the alphabet correctly but speed through the letters instead of a slow manner as she was instructed.

Based on my investigation I placed Stefanovic under arrest for DUI. I then transported her to BRPD.

Ofc Rafalako responded to BRPD as my Breath Test Operator. Ofc Rafalko and I conducted the 20 minute observation and then she was taken into the BAT room. Stefanovic refused to provide a breath sample. I read her Implied Consent Warnings, which Stefanovic advised she understood and still refused to provide a breath sample. I also read Stefanovic her Constitutional Rights which she advised she understood and would answer my questions without an attorney present. See DUI influence report.

Stefanovic is being charged under F.S.S. 316.193(1) for DUI.
