

<p>On 02/12/17 at approximately 1234 hours I was dispatched to 2055 NW 4th Ter in reference to a domestic trouble call. Upon my arrival, I met with Morgan Moszcienski and her roommates, Bianca Soto-Podesta, and Olivia Sloan. Moszcienski, Podesta, and Sloan stated that Moszcienski's boyfriend, Patrick Lane, pushed her during an argument.</p> <p>According to Moszcienski, she was going out with Lane and friends for her birthday on 02/10/17. An argument occurred between Moszcienski and Lane because an Uber ride was canceled. The incident caused Moszcienski and her friends to be stranded on the side of the road waiting for another Uber ride home. They all arrived at Moszcienski, Podesta, and Sloan's apartment located at 2055 NW 4th Ter at approximately 0300 hours.</p> <p>Moszcienski and Lane began to argue again inside the apartment because of the Uber ride. The argument escalated and Lane kicked the walls in the kitchen. Lane caused approximately \$300.00 in damage when he kicked two holes into the kitchen walls.</p> <p>Moszcienski and Lane decided to break up their one year dating relationship during the argument. Lane demanded all the gifts he ever gave to Moszcienski during the time they were involved in the relationship. Moszcienski and Lane continued to argue while gathering the gifts to be returned to Lane while in the area of the garage. Moszcienski, Soto-Podesta and Sloan stated that Lane pushed Moszcienski while they were in the garage area. Lane was threatening to damage Moszcienski's vehicle and making his hand like a fist near the vehicle. Moszcienski grabbed his arm to stop him from damaging her vehicle and Lane pushed her off. Moszcienski fell onto both her knees after Lane pushed her. I observed bruising to both of Moszcienski's knees. Moszcienski, Soto-Podesta, and Sloan said Moszcienski fell backward and hit her head on the cement floor of the garage. I did not observe any injury to Moszcienski's head. They stated that the police were not contacted the night of the incident and Moszcienski was not transported to the hospital for any medical attention.</p> <p>Written witness statements were completed by Moszcienski, Soto-Podesta, and Sloan. The statements were placed into evidence. I took photos of Moszcienski's injuries and submitted the photos into evidence. Bodyworn video was marked and submitted as evidence.</p>

<p>Moszcienski refused treatment from City of Boca Raton Fire Rescue. I contacted Lane who stated that he did not think he would be able to travel to the City of Boca Raton Police Department today in order to provide a statement. He stated that he went out with Moszcienski and her friends and roommates on 02/10/17. He explained that an argument occurred over an Uber ride. The argument continued when they arrived at Moszcienski's apartment. He added that Moszcienski grabbed his arm and he pushed her to get her of him and she fell. Lane stated that he had Moszcienski's cell phone when he woke up today. He had no idea why he had her cell phone, but returned it to Moszcienski on 02/12/17. Lane stated that he remembered kicking the kitchen walls and causing damage to the walls.</p> <p>On 02/15/17 at 1033 hours, Lane arrived at the City of Boca Raton Police Department. Lane was read his constitutional rights and agreed to speak with me. He stated that his prescription glasses were damaged during the altercation with Moszcienski. He said they were involved in a screaming match and Moszcienski began to hit him. He pushed her off his arms and then left. I asked if he understood how Moszcienski obtained the injuries to her knees and he replied, "I have he had no idea." Lane provided a written statement that was submitted into evidence. I observed burses on Lanes left bicep and scratches to the left side of Lane's neck. Photos of Lane's injuries were submitted into evidence. Due to statements made and the facts of the case, I determined Lane to be the primary aggressor. Lane actually and intentionally pushed Moszcienski without her permission with his hands. In addition, he willfully damaged real property belonging to Moszcienski. Lane was processed in the City of Boca Raton Booking area and was charged with Domestic Battery Florida State Statute 784.03(1a1), and Criminal Mischief 806.13(1b1). Statements made and facts of the case determined Lane to be the primary aggressor. Lane actually and intentionally pushed Moszcienski without her permission with his hands and willfully damaged real property belonging to Moszcienski.</p>
