On the 28th day of January 20 17 at 2237 AM PM

I was dispatched to 35 South J Street, in the City of Lake Worth, Florida 33460, in reference to a disturbance in progress. Myself, Deputy J. Hazel # 23888, Deputy J. Lasso # 19729 and Deputy I. Goodman # 26786 responded to this location at 2112 hours, regarding a white male, identified verbally as Patrick L. Wafler, causing a disturbance. During the incident, Patrick was intoxicated, knocking on several apartment doors, while screaming. Patrick was also throwing clothing items in the hallway. While I was on scene, Patrick would yell at a black male, identified verbally as Chad A. Williams. After several verbal orders to stop, Patrick complied, apologized and then said he would stop disrupting the orderly peace within the apartment complex.

Upon my second arrival at 2235 hours, Patrick was still intoxicated, drinking alcohol causing another disturbance. I heard Patrick yelling at someone about a bicycle. The victim, Chad A. Williams, said Patrick was striking his door while calling him a "Nigger." Chad told me that Patrick said he was going to fight him. Chad said prior to the incident, he was walking his dog. Patrick was standing on the third floor balcony, drinking an alcoholic beverage. When Chad brought his dog towards the apartment complex entrance, Patrick poured the unknown alcoholic beverage onto the ground, from the third floor balcony, causing some of the liquid to land on Chad's feet and dog.

I spoke with a witness, identified verbally as Katherine M. Gonzalez, who told me in a sworn written statement that she saw Patrick banging on Chad's apartment door, calling him a "Nigger" and attempting to fight him.

I made contact with Patrick at his apartment. When Patrick answered the door, he was holding a "Mike's Hard Lemonade" in his hand, which I know to be an alcoholic beverage. Patrick was slurring his speech, his eyes were glossy and slightly red and he was unsteady on his feet. Patrick exited his apartment to talk to me.

According to Patrick, Chad allegedly stole his bicycle approximately three weeks ago, and he has been upset about it. Patrick then told me that he let Chad borrow the bicycle to fix it, but he never returned it.
