PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I noticed a silver Chevrolet Malibu (GA tag CBX7787), with the brakes applied, sitting in the left-turn lane to go westbound onto Donald Ross Road from Alternate A1A. As I drove past the Malibu, I noticed the driver, who was in actual-physical control of the vehicle as he sat behind the steering wheel, was slouched over in the driver's seat. There was no other occupant in the vehicle.

OBSERVATION OF DRIVER:

After knocking on the door, the driver (Schweitzer Jr.) eventually woke up and pressed on the gas pedal. Schweitzer Jr. closed the approximate six-inch gap between my patrol vehicle and the Malibu, but was unable to drive further. Officer Warren and I continued to shout at Schweitzer Jr. and bang on his vehicle to get his attention. Schweitzer Jr. failed to follow commands to place the vehicle in park. Schweitzer Jr. continued to press on the gas. I went to the right rear passenger side door and shattered the window. I ordered Schweitzer Jr. to put the vehicle in park. Schweitzer Jr. complied

DRIVER'S STATEMENTS:

Post Miranda, Schweitzer Jr. stated he came from "place in West Palm Beach, a bar, and going to West Palm Beach Jupiter Florida." Schweitzer Jr. stated he was at a "Lift Nightclub in West Palm Beach," left the bar around 2:00am, and had a "whiskey around 1:30-1:45am."

ODORS:

I smelled the strong-odor of alcohol coming from his person.



ROADSIDE TASKS

HORIZONTAL GAZE NYSTAGMUS:

- Checkboxes for eye tasks: LT EYE-LACK OF SMOOTH PURSUIT, RT EYE-LACK OF SMOOTH PURSUIT, LT EYE-DISTINCT & SUSTAINED NYSTAGMUS AT MAX DEVIATION, RT EYE-DISTINCT & SUSTAINED NYSTAGMUS AT MAX DEVIATION, LT EYE-ONSET OF NYSTAGMUS PRIOR TO 45 DEGREES, RT EYE-ONSET OF NYSTAGMUS PRIOR TO 45 DEGREES

Other Observations:

While conducting the examination, Schweitzer Jr. swayed around and moved his head to follow my finger. Schweitzer Jr's. eyes pupils did not dilate with the light. His eyes did not track equally, and had resting nystagmus.

WALK & TURN:

HGN CONTINUED: There was a lack of smooth pursuit in both eyes and had distinct and sustained nystagmus in both left and right eye at maximum deviation. Schweitzer Jr. had an onset of nystagmus prior to 45 degrees in both left and right eye. There was no nystagmus in the vertical nystagmus check.

WALK AND TURN: I had Schweitzer Jr. get into the standing position. Schweitzer Jr. continually grabbed on Malibu for balance during the instruction phase of the task. As I explained the instructions, he stepped off the line to catch his balance. I instructed him to start the task. Schweitzer Jr. began the task and was immediately off balance and walked off the line. He struggled to keep his feet together during the task. He counted the steps softly, almost to an inaudible level. Schweitzer Jr. failed to turn around as instructed. Schweitzer Jr. raised his arms for balance and grabbed onto the Malibu and marked patrol car to keep himself upright.

ONE LEG STAND:

I instructed Schweitzer Jr. on how to complete the One Leg Stand task. Schweitzer Jr. understood the instructions and began on command. During the task, Schweitzer Jr. swayed and used his arms to balance himself. Schweitzer Jr. needed to put his foot down and grab onto the Malibu to catch his balance various times throughout the task. While completing the task, Schweitzer Jr. stopped counting out loud and was reminded to continue counting out loud.

FINGER TO NOSE:

I instructed Schweitzer Jr. on how to complete the finger-to-nose task. As I was providing Schweitzer Jr. the instructions, he would begin the task by tilting his head back and closing his eyes. I reminded Schweitzer Jr. to start when I instructed him to. After completing the instruction phase for Schweitzer Jr., he began on command. Schweitzer Jr. was able to match the finger to his nose, however he pushed his finger into his nose, rather than simply touching it, as shown and instructed. As Schweitzer Jr. was completing the task, he moved his head from being tilted up back to alignment.

ROMBERG/ALPHABET:

I instructed Schweitzer Jr. on how to complete the Romberg Alphabet task. Schweitzer Jr. stated he knew the American Alphabet. I instructed Schweitzer Jr. to recite the alphabet from A to Z in a non-rhythmic, singing or patterned manner. Schweitzer Jr. stated he understood. Schweitzer Jr. started prior to giving command. Schweitzer Jr. started out in a pattern and moved to singing the alphabet. Schweitzer Jr. caught himself singing at L,M,N,O,P and apologized, picked up at Q and sang the rest of the alphabet.


