Responded to a Motor Vehicle Crash involving a white Ford F350 bearing Florida Tag LJTD24 driven by Paul Revels (identified via FL Driver's License) and white Mercedes GL300 bearing Florida Tag EVIZ80 driven by Grant Proby Jr. Both parties participated in crash investigation. 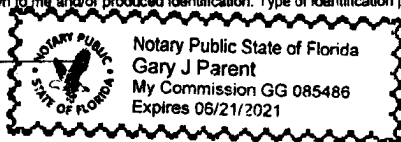

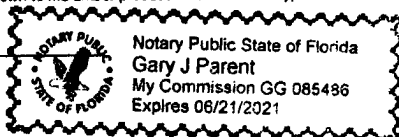
