NARRATIVE:



On 05/26/2017 at approximately 2345hrs I was traveling eastbound on State Road 80 approaching the turnpike over pass, in unincorporated west Palm Beach FL. I was in an unmarked PBSO issued patrol vehicle when I observed a red Chevy Blazer pass me at a high rate of speed (estimated 80mph in a 50mph zone). I was unable to obtain a pace speed due to the red traffic light at the turnpike exchange exit. The red blazer was traveling in the #2 lane but abruptly changed lanes to the #3 In. The traffic light had already been Red for well over a minute. The Driver of the Blazer hit the break slowing but as it approached the stop bar the driver accelerated rapidly running the red light. I pulled behind the vehicle and immediately activated my red and blue patrol lights on my unmarked vehicle. The driver came to slow stop at the intersection of State Road 80 and Cleary Rd in the left turn lane.

I made a driver side approach and made contact with the sole occupant, Paul Mathew Drake WM DOB 07/13/1977, who identified himself to me with a FL Driver's license. As I spoke to Drake I immediately noticed he had blood shot eyes, slurred speech, and he was emitting an odor of an unknown alcoholic beverage from his breath (I know this based on my training and experience). Drake then began to argue and justify running the red-light because he was unaware that I was in an unmarked patrol vehicle. He stated if he knew I was a cop he wouldn't have ran the red light. I asked Drake if he had been drinking alcohol tonight, he advised he only had 2 drinks.



DRAKE failed to respond to my question. A search of his person reveled from his right rear pocket, a plastic bag which contained a green leafy substance which I immediately recognized through my training and experience as marijuana. The total weight of the suspected marijuana was less than 4.36 grams. The recovered suspected marijuana was field tested utilizing a PBSO issued test kit which proved positive for THC.</p> <p>Therefore, with the evidence recovered from the vehicle, I find additional probable cause for the arrest of "DRAKE" who was unlawfully and knowingly in actual or constructive possession of less than 20 grams of a material, compound, mixture or preparation which contained cannabis, commonly known as marijuana, a controlled substance, contrary to Florida Statute 893.13(6)(b), a 1st degree misdemeanor and was unlawfully and knowingly in actual or constructive possession of the "PLASTIC BAG", which was drug paraphernalia being used for storage of a controlled substance, contrary to Florida Statute 893.147(1), a 1st degree misdemeanor.</p>

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I was called to the scene of a traffic stop at the intersection of Southern Blvd & Cleary Road, which is located in unincorporated Palm Beach County, Florida. I arrived at the scene at approximately 23:53hrs. Det. M. Frazao #9538 relayed to me, and completed a written signed sworn supplemental Probable Cause Affidavit, that he had stopped the defendant's vehicle, a 1999 Chevy Trail Blazer bearing FL tag HYD-X56, because the defendant passed him at an estimated 80/50mph zone. and then ran a red light at Southern Blvd and the Turnpike entrance. Det. Frazao noticed that the defendant had articulable indicators of impairment, so he called for a DUI unit to conduct a possible DUI investigation. Det. Frazao identified the defendant, to me, as the driver and sole occupant of the vehicle, at the time of the stop.

OBSERVATION OF DRIVER:

Upon making contact with the driver who was identified as "PAUL MATTHEW DRAKE" by his Florida driver license, I immediately detected an obvious and strong odor of an unknown alcoholic beverage emitting from his person and face area along with odor of suspected marijuana. This odor intensified as I spoke to Paul. He had glassy, glazed, and blood shot eyes. Paul's speech was slurred, slow, and thick, and at times difficult to understand. Paul's movements were slow and deliberate while exiting his vehicle and used the door for support. He was also lethargic with poor coordination. Paul had an unsteady gait while walking towards my patrol vehicle.

DRIVER'S STATEMENTS:

Pre-Miranda: Paul stated he drank 1, 2, maybe 3 beers bu wasn't drunk.

Paul refused to provide a breath sample after Implied Consent, which he stated he understood. Paul refused Q&A.

ODORS:

A strong and obvious odor of an unknown alcoholic beverage was emitting from his person and face area which intensified as I spoke to them. additionally an odor of marijuana was detected.

GENERAL OBSERVATIONS

SPEECH: Paul's speech was slurred, slow, and thick, and at times difficult to understand.

ATTITUDE: talkative, polite, annoyed, belligerent, threatening

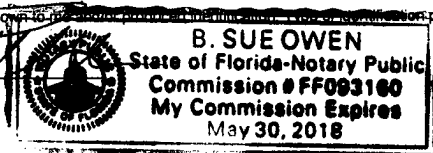

Other Observations:

Paul would sway roughly in a side to side front to back pattern throughout the task. Paul did touch the tip of the pen as directed to positively identify the point to be tracked. Paul was reminded numerous times to track the pen with his eyes only. He failed to keep his head still while tracking the stimulus and stated he was using his peripheral vision. Paul did not have VGN but did have LOC.

WALK & TURN:

I explained and demonstrated the instructions for the "Walk & Turn" to Paul who stated the he understood. Paul would sway roughly in a side to side, front to back pattern throughout the demonstration phase. Paul could not maintain his balance while listening to instructions and stepped out of the stance during the demonstration to catch his balance. Paul started the task before being instructed to do so. Paul, on the first pass missed heel-to-toe steps and stepped off the line, using his arms for balance by raising them more than six inches. On the return, Paul again would miss heel-to-toe steps and stepped off the line. Additionally, he performed the incorrect number of steps.

ONE LEG STAND:

I explained and demonstrated the instructions for the "One Leg Stand" to Paul who stated that he understood. Paul would sway roughly in a side to side, front to back pattern throughout the demonstration phase. He continued to sway while balancing on one leg. Paul used his arms to balance raising them more than 6 inches from his sides. Paul failed to count out loud by thousands as instructed. He put his foot at down to regain balance before the 30 seconds had elapsed.

FINGER TO NOSE:

I explained and demonstrated the instructions for the "Finger to Nose" task to Paul who stated that he understood. He would sway roughly in a side to side, front to back pattern throughout the demonstration phase. Paul did not keep his eyes closed and had to be reminded numerous times. Paul's index finger did not touch the nose on 3 of the 6 attempts. Paul hesitated and searched for the tip of his nose prior to touching the tip. Paul used the hand other than that which was called. The sequence used for this task was L, R, L, R, L, L.

ROMBERG ALPHABET:

I explained and demonstrated the instructions for the "Rhombert Alphabet" task to Paul who stated that he did not know the alphabet. I had Paul count 1 to 30 to compensate for his deficiencies. Paul would sway roughly in a side to side, front to back pattern throughout the demonstration phase. Paul would not keep his eyes closed and had to be reminded numerous times. He would sway more than 2 inches. Paul incorrectly recited the numbers.

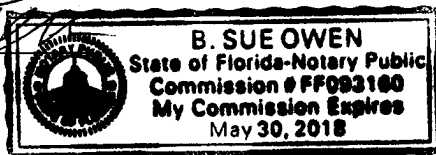
