

I initiated my lights in an attempt to stop the vehicle due to the erratic driving. I approached the vehicle and made contact with the driver later identified through D.A.V.I.D as W/M Peter D Andolpho 01-08-65. He had glassy eyes and a slurred speech and what appeared to be vomit on his chin, shirt and shorts. When I asked how he was feeling he advised me that he was lost. I asked if he had anything to drink and he advised a couple. I asked for his license and Andolpho took a few seconds looking through his wallet. I then contacted Investigator Chiquito #18334 who assumed the investigation.</p> <p>This ended my involvement in the case.</p>

In the defendant's right front pocket I located and removed a clear, plastic tube with a white cap that contained a green, leafy substance, presumed marijuana from my training and experience, and a foil pipe with residue. The green leafy substance field tested positive for marijuana using a Duquenois Reagent Marijuana test kit when the reagent turned a bright purple color indicative of the substance being marijuana. The weight of the marijuana was 1.5 grams, with a total package weight of 10.1 grams.</p> <p>The marijuana and the clear plastic tube containing the foil pipe were packaged and placed into evidence.</p> <p>Based on the above set of facts and circumstances, probable cause exists to find PETER DONALD ANDOLPHO was knowingly in actual or constructive possession of 20 grams or less of a material, compound, mixture or preparation which contained cannabis, commonly known as marijuana, a controlled substance, contrary to Florida Statute 893.13(6)(b). (1 DEG MISD)</p> <p>Additionally, PETER DONALD ANDOLPHO did use or possess with intent to use foil pipe with marijuana residue, drug paraphernalia, for injecting, ingesting, inhaling, or otherwise introducing into the human body a controlled substance, contrary to Florida Statute 893.147(1)(b). PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 11/19/2017, at approximately 19:09 hours, I responded to the intersection of Jog Road and Lake Worth Road in the City of Greenacres, located in Palm Beach County, Florida to assist with a traffic stop and a possible impaired driver. Upon arriving on scene I made contact with Deputy Anthony Norris #24996 who relayed to me, and completed a sworn written probable cause affidavit, the following: He was on routine patrol in an unmarked PBSO vehicle and traveling west on Lake Worth Road at the intersection of Jog Road when he observed a white Volkswagon Passat, bearing Florida tag HXVS05, at the traffic light next to him start rolling forward and almost strike the vehicle in front of it. When the light turned green to proceed west through the intersection, the vehicle paused while other traffic continued and then the driver accelerated through the light and made an abrupt turn into the parking lot at 6535 Lake Worth Road at the PNC Bank. D/S Norris made contact with the driver, identified as PETER DONALD ANDOLPHO (defendant) DOB: 01/08/1965 by his Florida issued driver license. Deputy Norris observed obvious and articulable signs of impairment and requested a DUI unit. See Deputy Norris' supplemental P/C for details.

OBSERVATION OF DRIVER:

When I arrived on scene the defendant was seated in the vehicle, in the driver's seat, and there was a male seated in the front passenger seat. The vehicle was still running. After approaching the defendant on the driver's side I observed that his eyes were red, bloodshot and glassy. His speech was heavily slurred and slow and there was a strong and obvious odor of an unknown alcoholic beverage emanating from within the vehicle. I asked the defendant to step out of the vehicle and I relocated him to the front of my patrol car. He was slow to respond. With my in car video system activated I continued to speak with the defendant out of the vehicle and I could smell the strong and obvious odor of an unknown alcoholic beverage emanating from his breath as he spoke with me and the odor became stronger. The defendant was very talkative, argumentative and repeated himself alot. He did not follow simple instructions if keeping his hands out of his pockets and down to his side. I could see he had a stain on the front of his shirt that appeared to be vomit.

DRIVER'S STATEMENTS:

The defendant stated that he spent the day t the marina in Lake Worth with friends and he didi consume approximately four Miller Lite beers while at the marina. He swayed very slightly in a front to back motion when he was asked to stand with his feet together. He denied having any medical issues or taking medication. I asked the defendant if he would submit to voluntary SFST's and he verbally consented. He interrupted as I demonstrated and gave instructions and he had difficulty remaining in the instructional stance. SEE Probable Cause PAGE 2 for further.....

ODORS:

Strong and obvious odor of an unknown alcoholic beverage emanating from defendant's breath that became stronger as the defendant spoke to me.

GENERAL OBSERVATIONS

SPEECH: Slow, slurred, mumbled, incoherent

ATTITUDE: Argumentative, Repeating himself, mood swings

CLOTHING: Gray shirt stained with what appeared to be vomit, Blue shorts, Tan boat shoes

MEDICAL/OTHER: Defendant denied having any medical conditions, injuries or physical impairments. Defendant denied being on any medications or taking any medications. After being placed under arrest he stated he had "a bad shoulder".




